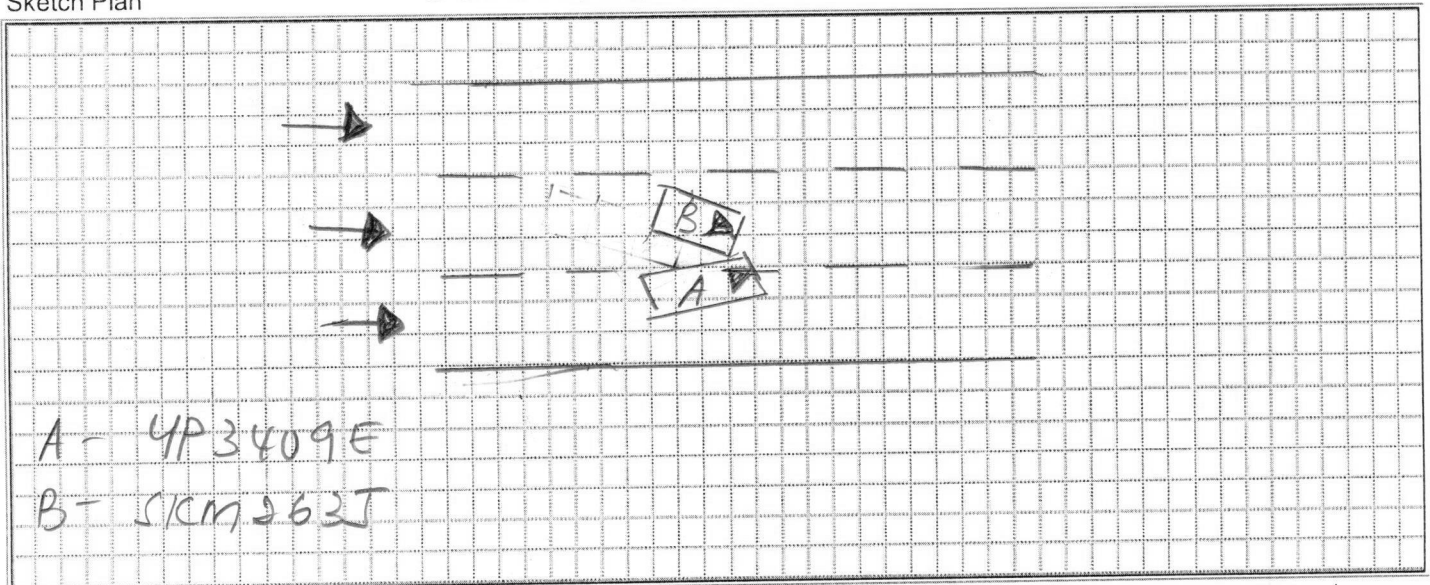

SENGKANG EAST RD



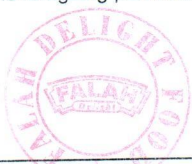
