Dear Kenneth,

1. We refer to the above matter wherein we act for the Plaintiff and Cooma & Rai act for the Defendant.
2. Please be informed that parties have agreed to appoint you as the Single Joint Expert (“SJE”), further to the accident involving SLT 8181K and GBG 4715J at or along the carpark of Nouvel 18 B2 on 2 June 2021.
3. We shall be grateful if you could conduct a re-inspection on the Plaintiff’s vehicle SLT 8181K. Thereafter, you would be required to produce your re-inspection report, inter alia, the estimated costs of repairs and number of days for repairs for the Plaintiff’s vehicle SLT 8181K, as well as the reason/s for the same.
4. We enclose herewith the following for your necessary action:
 - (a) GIA report of the driver of SLT 8181K filed on 3 June 2021 of 16 pages, which amongst others also consist of a copy of sketch plan of 1 page, handwritten statement of 1 page, photographs showing damages to SLT 8181K of 10 pages and addendum of 1 page;
 - (b) GIA report of the driver of GBG 4715J filed on 2 June 2021 of 17 pages, which amongst others also consist a copy of sketch plan of 1 page, handwritten statement of 1 page, photographs showing damages to GBG 4715J of 12 pages and certificate of insurance of 1 page;
 - (c) Proforma invoice from JP Concept dated 15 July 2021 for \$4,151.60 of 1 page;
 - (d) Vehicle damage inspection report from Pro Plus Automobile Engineers dated 7 July 2021 of 5 pages together with inspection photographs of 12 pages;
5. Kindly let us have the SJE report soonest possible.
6. Please also forward to the Defendant’s lawyers, M/s Cooma & Rai, the said SJE report upon completion as the Defendant will be bearing ½ share towards payment of the SJE report. If you require further documents from the Defendant, do liaise with M/s Cooma & Rai for the same.
