In preparing his report, we would like Mr. Kong to also address the following:

1. To confirm that the damage from the accident is confined to damage to the TMA mounted on the vehicle no. YM9547R.
2. To confirm that the "repairs" to the vehicle no. YM9547R is therefore only confined to replacement of the TMA. value of the TMA at the time of the accident, taking into account its age at the time of the accident and depreciation.
3. To confirm that when a brand new TMA unit is bought, the sale price typically would include installation costs.
4. To estimate the value of the TMA at the time of the accident taking into account the purchase price of the TMA, the age of the TMA at the time of the accident, the average useful lifespan of the TMA and depreciation.
