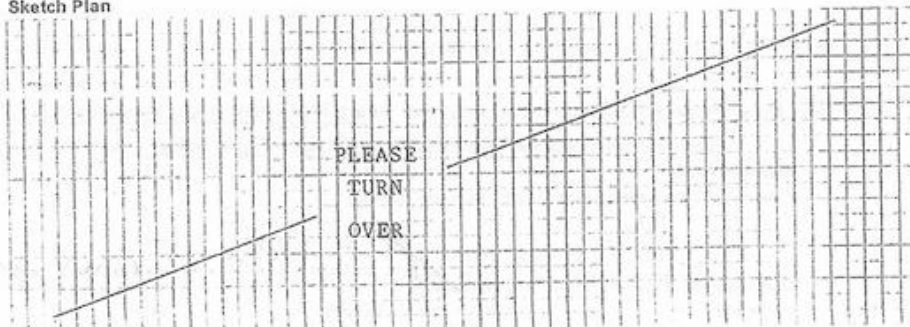

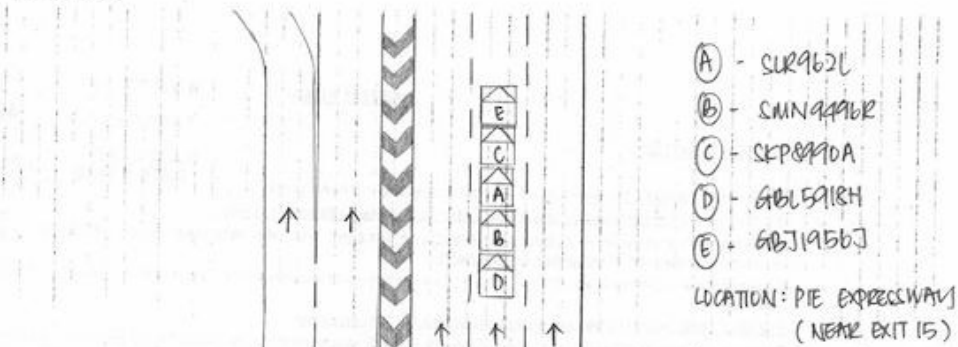

VEHICLE RENTAL AGREEMENT

This Vehicle Rental Agreement (this "Agreement") is made and entered into on this
28 DAY OF Jul 2022

1. KINETIC HOLDINGS PTE. LTD. (REGISTRATION NO. 201618392N), a company incorporated under the laws of Singapore and having its registered office at 9 Tagore Lane #03-21 9@Tagore Singapore 787472 (hereinafter referred to as "Owner")

AND

2. LIM DE MAL, RON, Nric No./PP No. : S9125077B) of
BLK 676 CHOA CHU KANG CRESCENT #05-451 SG680676
DOB 10/07/1991 (Each individually a "Party" and collectively, the "Parties")

WHEREAS:

- The Owner is in the business of renting and leasing of private motor vehicles ("Vehicles") in the Republic of Singapore.
- The Hirer wishes to lease from the Owner Vehicles and operate as a licensed motor vehicle driver under any ride-hailing application or program used on mobile phone devices, or to operate a limousine driver or for the Hirer's own personal use.
- In consideration of the promises and mutual covenants contained herein, the Owner and Hirer agree to enter into this Agreement to explicitly set out the terms of the Hirer's leasing of the motor vehicles with the Owner.

NOW THEREFORE, in consideration and subject to the terms and conditions contained in this Agreement, the Parties agree as follows: -

1 AGREEMENT TO RENT

- 1.1. **Rental Terms** : The Owner agrees to rent to the Hirer the Vehicle described in Schedule 1 of this Agreement in accordance with the terms and conditions stated in this Agreement herein.

2 COMMENCEMENT AND DURATION OF RENTAL

- 2.1. **Rental Period** : The Hirer shall rent the Vehicle from the owner from the date indicated in Clause 2.1 of Schedule 1 of this Agreement (the "Commencement Date") and this shall automatically renew on a weekly basis until it is terminated in accordance with this Agreement (the entire duration comprising the "Rental Period").
- 2.2. **Minimum Rental Period**: The Hirer shall rent the Vehicle from the Owner for the minimum length of time as specified in Schedule 1. Accordingly, in the event that the Hirer returns the Vehicle prior to the end of the Minimum Rental Period, the Hirer will be required to pay the full Rental Fee applicable for the remaining period up to the end of the Minimum Rental Period and the deposit will be forfeited. 7 days notice can only given after the contract end date.

3 RENTAL

- 3.1. **Rental Fee**: Pursuant to Collection, the Hirer shall pay to the Owner a fee calculated on a weekly basis for the rental of the Vehicle (a "Rental Fee") as stated in Clause 4.1 of Schedule 1. The Rental Fee shall be calculated on a weekly basis, and shall include the following:
- Unlimited mileage;
 - Service and maintenance;
 - Road tax;
 - Motor insurance coverage (excess payment) subject to the terms stated below; and
 - 24 hours breakdown and emergency service (in Singapore only);
- 3.2. **Collection**: The first week's Rental Fee is payable immediately after the week from the commencement of the Rental Period.
- 3.3. **Additional Driver Fee**: The Hirer shall incur additional charges should there be more than one designated Driver (as defined below) to the Vehicle as detailed below in Clause 4 of the Agreement, and each Additional Driver (as defined below) shall be charged a weekly fee of \$25 per additional driver, inclusive of GST. This fee for the Additional Driver shall be in addition to the Rental Fee, as is reflected in Clause 4.2 of Schedule 1.
- 3.4. **Rental Payment Date**: The Hirer shall pay to the Owner the Rental Fee on the Rental Payment Date as stated in Clause 4.3 of Schedule 1. The date of receipt of any payment made by the Hirer to the Owner shall be the actual date of receipt by the Owner.

Brief Details.

On 09/09/2022, at about 1046hrs, at PIE toward Changi Airport, beside upper serangoon exit. I was a gojek driver with one passenger in my Vehicle (Order No: RB-120688-5918623). I was travelling at the second right lane and the traffic was very heavy with wet surface as it was drizzling. It was a Chain Collision which involve First vehicle GBJ1956J then SKP8990A then my vehicle (SLR962L) then followed by the fourth Vehicle SMN9496R then last vehicle GBL5918H. The accident started when first 2 vehicle had completely stop and I also completely stop my vehicle at stationary, suddenly the fifth vehicle collided with fourth vehicle then came collided with the rear of my vehicle which then I collided with the second follow by first vehicle. Only my vehicle was tow away and my passenger was not injury. I felt unwell on my lower back after the collision and went to hospital for X-RAY at 1300hrs by myself without ambulance conveyed, and was given MC 7 days. I did not have the other parties particular as they refused to exchange the particulars.
