CONTINUATION OF REPORT

Brief Details.

On 05/09/2022 at about 0830hrs, I was riding my motorcycle FBP903L with my wife as my pillion one lane 1 along CTE towards City before the exit of Ang Mo Kio Ave 5 near lamp post 18F when we met an accident. During the incident, I was riding on the left side of lane 1 as the traffic was heavy to allow other vehicle to pass on my right. While riding my motorcycle, a car (SFD2828Z, Grey Audi) on my left (lane 2) signalled wanting to make a lane change. At that point of time, I was riding close to the said car and was probably in the driver's blind spot.

As I was very close to the said car, I did not expect the driver to make the lane change as it was unsafe. I decided to maintain my speed and that was when the car made the lane changed. As I was too close, I was not able to brake on time to avoid collision. The said car did not managed to make a complete lane change as it was slanted and it's position was in between lane 1 and lane 2. As I was already too close to the said car, I ended up colliding into the right rear bumper of the said car. The impact caused my motorcycle to topple on the left causing both my wife and I to fall. My wife and I had our legs stuck underneath the motorcycle and I sustained some abrasions on my left shoulder, arm and hand.

The said car which I collided into continued driving and only stopped a few meters ahead. I am not sure if the driver of the said car was aware that an accident had occurred. The driver of the said car is a female Chinese. She got off from her car and made a check. She appears fine and uninjured. She claimed that she had signalled and saw us coming in but still far from where she was and took the chance to change.

After the accident, a few people came to help us and brought us to the side of the road before EMAS recovery came to assist. Shortly after, the Traffic Marshall came and took down all our particulars and called the ambulance. My wife received medical attention from the paramedics but did not want to be conveyed as she was not seriously injured. Both the driver and I exchanged our particulars and took pictures of the accident.

The Traffic Police came and advised us to lodge an accident report with our insurance company. After the accident, my wife complained of pain on her left ankle and was having difficulty in walking hence both my wife and I proceeded to Woodlands Polyclinic to seek medical treatment for our injuries. We were subsequently referred by Woodlands Polyclinic to Khoo Teck Puat Hospital for further checks. Both my wife and I were issued with 3 days of MC by the A&E doctor. I have informed my insurance company of the accident and was advised to lodge a Traffic accident report.
