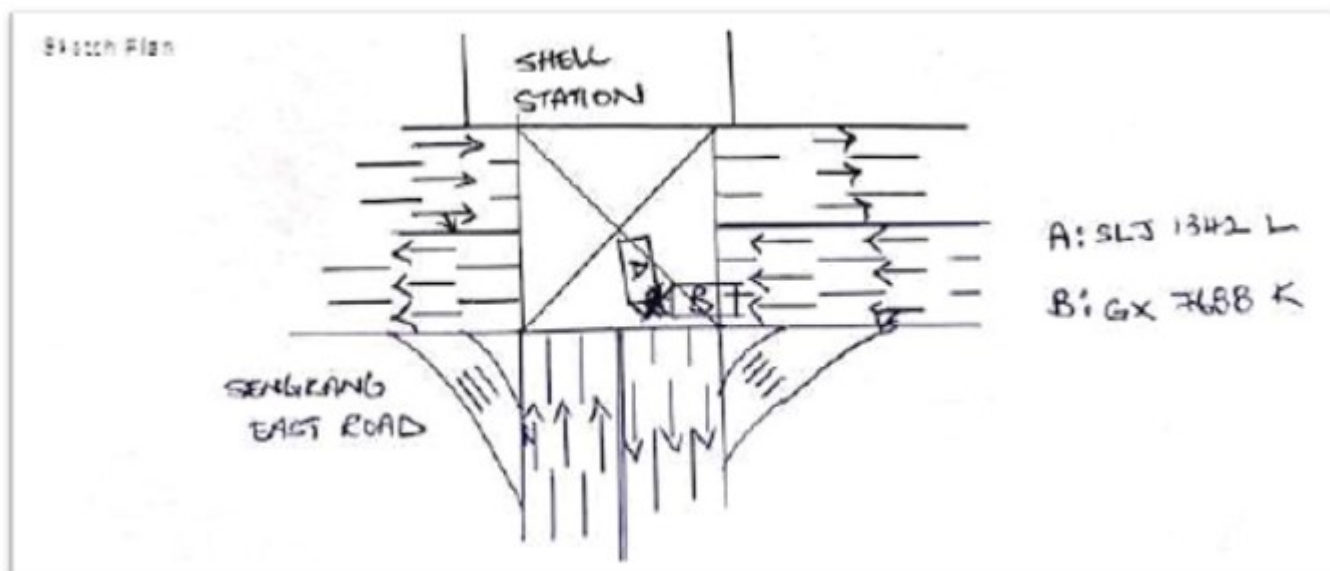

I TOOK THIS PAX BOOKING REFERENCE NO RB191620-7271919 (GOJEK) NAME MISS PATSY CONTACT NUMBER: [REDACTED] FROM TAXI STAND 109, BEDOK NORTH TO 10 SENGAKANG SQUARE, PICK UP @ 0505AM AND PROCEED TO THE DESTINATION. I WAS TRAVELLING TOWARDS SENGKANG EAST NEAR SHELL STATION AND I TOOK ON THE RIGHT LANE AS I AM TURNING TO SENGKANG SQUARE, THE TRAFFIC LIGHT WAS GREEN AND I GAVE SIGNAL, THE ROAD IS CLEAR BEFORE TURNING SUDDENLY A VAN VEHICLE NUMBER GX7688K HIT THE LEFT SIDE OF THE CAR AS I ALMOST COMPLETE MY TURNING, PROBABLY THE VAN DID NOT SWITCH THE LIGHT WHILE CROSSING THE JUNCTION OR IT COULD BE THE RED LIGHT ON THE OTHER SIDE OF THE ROAD.
