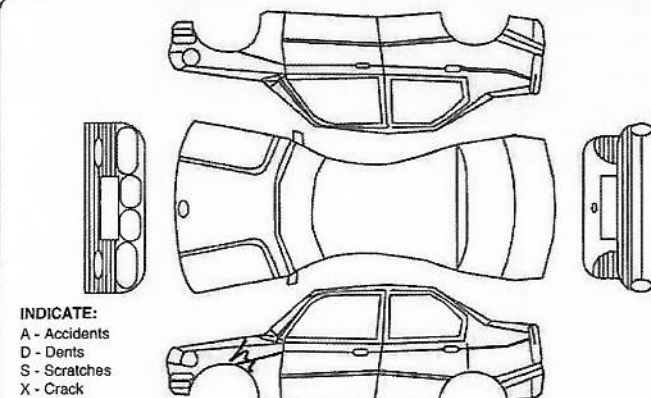

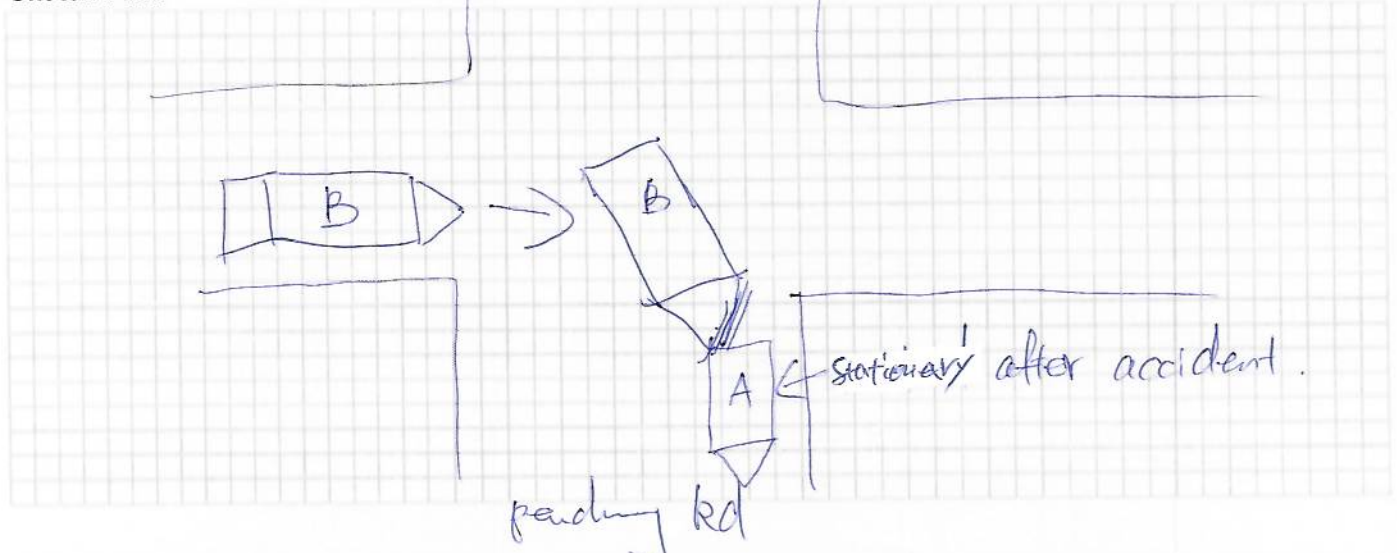

Describe Circumstances of the Accident

My vehicle was stationary along Pending Road, waiting for a tow truck after accident. A bus made a right turn at a junction and collided into ~~the~~ the rear of my vehicle even though the hazard light was turned on.

Declaration
