

Brief Details.

On the 17/09/2022 at about 4.15 pm, I was riding my motorcycle no. FBR 3957 B along lane 3 of Scotts Road towards the direction of Stevens Road. All of the sudden, there was a blue motortaxi no. SH 7822 G which was on lane 2 who without giving any signal or warning tried to cut into my lane 3 when I had the right of way and the said motortaxi no. SH 7822 G front left corner, knocked onto the middle portion of my motorcycle causing me to fall and suffer injuries. I was conveyed by ambulance to Tan Tock Seng Hospital and was given 2 days MC from 17/09/2022 to 18/09/2022 and I went to seek further medical treatment for my injuries and was given further 2 days MC from Faith Clinic (Jurong West) as I'm still in pain as the result of the injuries due to the accident.

I enclosed herewith the 2 MC from Tan Tock Seng Hospital and Faith Clinic (Jurong West) totaling 4 days of MC and 4 coloured photographs taken at the scene of accident.

I wish to claim against the insurance company of the motortaxi no. SH 7822 G for my injuries and damages to my motorcycle.
