Brief Details.

On the 16/07/2022 at about 0745hrs, I was driving my blue Hyundai Ioniq taxi bearing plate SHA3499A on the left most lane of Upper Jurong Road queuing to turn into SAFTI MI. At that point of time, there was a long queue of vehicle waiting to turn into SAFTI MI. Out of the sudden, I felt an impact on the rear of my vehicle which caused my vehicle to knock into the vehicle in front of me.

I went down to take a look and took some photos. A White Toyota bearing GBC5484P have rear ended my vehicle and caused my vehicle to rear end a White Honda Civic bearing plate SJR42R in front of me, it also caused the Honda Civic to rear end a Silver Toyota bearing plate SMM9027S. Shortly after, ambulance came over and conveyed me to Ng Teng Fong Hospital. I was discharged on the same day and was given 05 days of MC from 16/07/2022 to 20/07/2022. After which, I was contacted by TP to inform me that my vehicle has been towed back to TP compound and told me to lodge a traffic report regarding the accident.

I would like to state that I suffer injury such as pain on my left knee. My vehicle suffer dents on the rear boot and bumper area and dents on the front bumper area.

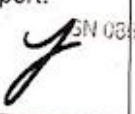
