



STATEMENT BY S0198953G TAN SWEE KEE

On Saturday, 24 September, 2022, at about 09.35 am, I was driving my car SDK8208K and leaving the car park on the 4th floor of the Lorong Ah Soo market & hawker centre.

My wife was the front passenger. My auntie was in the rear seat.

Lorong Ah Soo market & hawker centre is a regular place where we do our marketing and have our meals.

I am the owner and driver of SDK8208K at the time of the incident.

As I was driving down the spiral car park ramp after passing the 3rd floor, another vehicle SMM6193P, a white Hyundai, was on its way up the ramp. My car's headlights were automatically on at the time.

After I passed SMM6193P, I suddenly felt an impact on the right side of my car. Car SMM6193P crashed into my car, causing extensive damage.

As it was just a narrow two-lane ramp, one side for vehicles going up and the other for vehicles coming down, and in order not to hold up traffic, both parties drove to a nearby open car park.

The driver of SMM6193P refused to admit fault that he was driving quite fast up the narrow ramp and too near to the dividing white line between the 2 lanes. This resulted in him hitting the rear half of the right side of my car, which bore the main impact.

As the driver of SMM6193P sounded unreasonable and adamant that he was not at fault, I told him that I would report the accident.

His car had a broken right headlamp shade and some scratch marks around the right mudguard of his car, just below the broken right front headlamp.

The right side of my car, from the rear end of the driver's door to the entire rear door, was badly damaged.

The main impact point on the right side of my car clearly shows it was the right front side of SMM6193P that had hit the right rear half of my car. The video clip from the in-vehicle camera will bear this out.

I requested to exchange drivers' particulars, but the SMM6193P driver declined, saying I already had his car number.

After I informed the driver of SMM6193P that I would report the accident, I drove off. I saw the driver of SMM6193P walking away from his parked car.


