



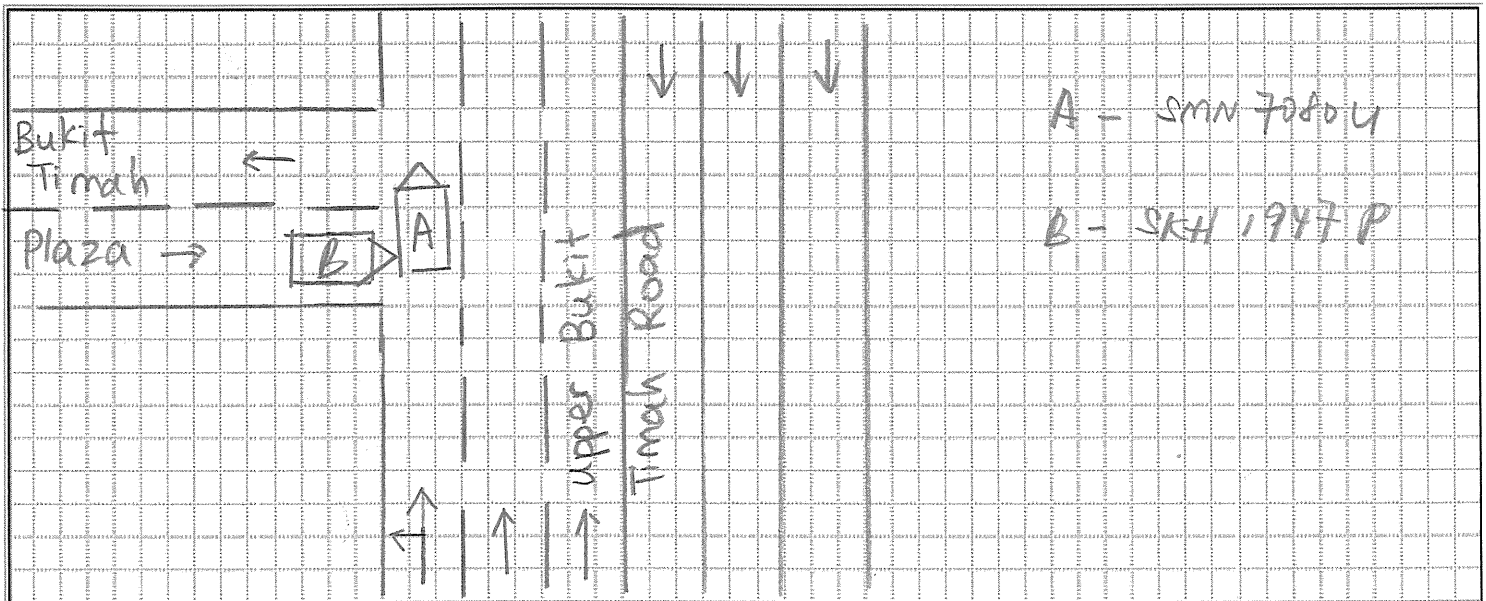

Sketch Plan




