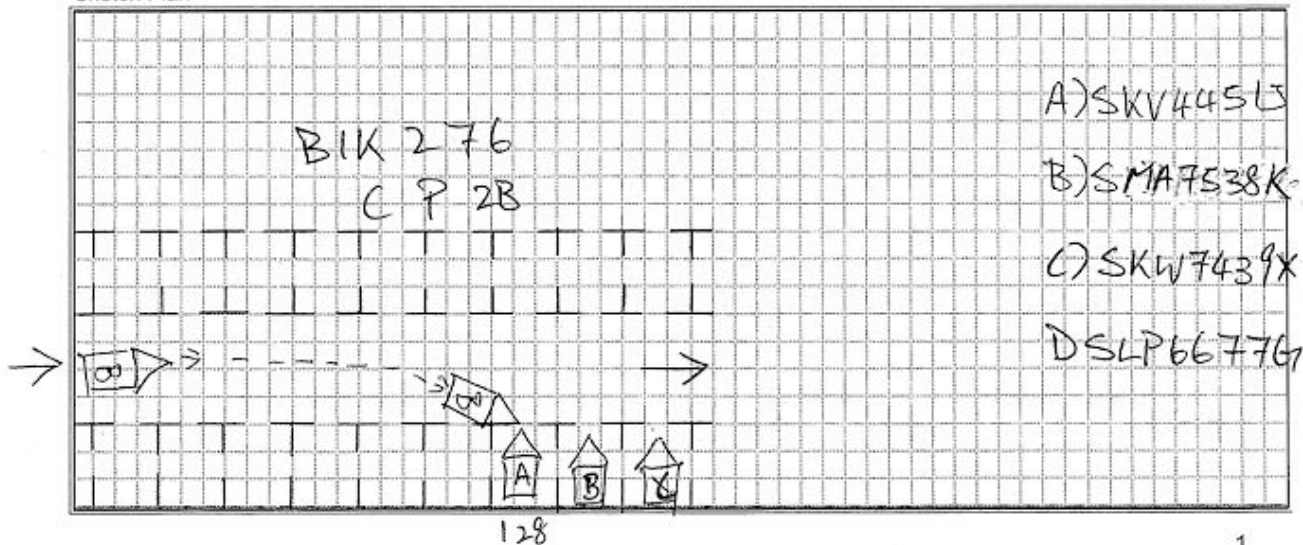



Sketch Plan







Brief Details.

On the above mentioned date, time and place, I discovered the below mentioned items were missing. I made a search but to no avail. Thus, I am lodging this report for record/replacement purposes.

On 24/09/2022, at about 1145h, my husband received a call from our neighbour informing that our vehicle (SKV4451J) which was parked at Blk 276 Jurong West Street 25 MSCP was slightly damaged. My husband and I then went down to the carpark to take a look. Our vehicle was parked on Deck 2B Lot 128. We discovered that our car's bumper was slightly detached and there was paint chip-off on the front portion of the car. My car was also slightly displaced from its original position. My front car plate was missing and nowhere to be found in the vicinity.

We discovered that a note was left on the vehicle parked in Lot 129 (SMA7538K). The note was left by a 'Neo Wei Ren' who stated that he fell asleep and crashed into the car at 0400h. He left his contact number HP: 81829780 and car plate SLP6677G. I contacted him on Whatsapp and he provided me with his IC no. S8530587E as well as driver's license. He informed that my car plate was still intact when he left the scene.

Another vehicle (SKW7439X) which was parked at Lot 130 also suffered some dent on its left side. The owner of this vehicle was also at scene, hence we decided to lodge a report together for the purpose of insurance claims, as advised by the staff of my car workshop. I am not aware of who the owner of vehicle SMA7538K is.

The in-car camera inside my vehicle was not switched on hence the incident was not captured. I am not injured in the course of this accident. The last time I saw my car intact was on 23/09/2022 at about 1800h.
