### **Rental Agreement**

1. This rental agreement is enacted for the purpose of Hirer's lease for a Peugeot 5008 Diesel, with license plate number, SMY6509A.
2. Hirer Details:
  - a. Name: Ahmad Tarmizi Bin Marlian
  - b. NRIC/ROC: S1171373D
  - c. Relief driver: Ahmad Safiy Bin Ahmad Tarmizi (S9701270I)
3. Rental duration: 01/07/2022 – 30/6/2023
4. Deposit: \$500.00
5. Rental rate: \$120/day for PHV purposes and allows 1 relief driver.
6. Hirer will be liable for all fines and summons incurred throughout the entire lease tenure indicated in point 3. He/She shall exercise due diligence to ensure that payment is made to the relevant authorities.
7. In the event of an accident, throughout the lease tenure, an accident excess of :
  - a. SGD\$2,000.00 (Own damage) and SGD\$2,000.00 (3<sup>rd</sup> party) will be levied should the accident be in Singapore and with another Singapore registered vehicle. Accident excess will be refunded if the result of the insurance claim against 3<sup>rd</sup> party is ruled 100% in 4G Auto's favour.
  - b. SGD\$6,000.00 will be levied should the accident happen out of Singapore or involves another vehicle that is not Singapore registered. Accident excess will be refunded if 4G Auto is successful in claiming 100% damages incurred against the 3<sup>rd</sup> party vehicle of foreign origins.
8. Hirers are the sole named drivers for the said vehicle, SMY6509A. The insurance purchased is for the above named drivers and as such, shall permit no other drivers to use the said vehicle, SMY6509A, for any purpose.



9. Upon completion of lease tenure, the vehicle shall be returned with the same fuel level. Failure to do so will result in a SGD\$50.00 levy per  $\frac{1}{4}$  tank or part thereof. The car shall be returned in the condition it was taken over. Failure to do so will result in the Hirer being liable for the repair costs with exception to the following:
  - a. Minor scratches that does not exceed the depth of the paint on the exterior of the car.
  - b. Dents that are less than or equal to the size of a Republic of Singapore 50 cent coin.
10. The rental paid entitles the Hirer to drive the car only in the countries of the Republic of Singapore and Malaysia. Should the car break down or meet with an accident in Malaysia, the Hirer is responsible to pay for the fees required to transport the car back to 4G Auto's designated workshop.
11. The Hirer is to strictly abide by the maintenance schedule indicated by the service sticker attached to the car/or Whatsapp message sent by 4G Auto's representative.
12. The Hirer shall immediately inform Kelly Ong, Managing Agent of 4G Auto, @ +65 9450 0775 should there be any issue at all with the car.
13. Failure to abide by any of the above clauses will result in the forfeiture of SGD\$500.00 deposit paid by the Hirer. Hirer shall also be liable to pay for any damage, losses or repairs deemed necessary by 4G Auto.
