**Brief Details.**

On 14/09/2022 at about 1130hrs, I was driving my vehicle bearing registration number SM5302 along Jalan Ahmad Ibrahim towards Tuas at the cross junction of Jalan Ahmad Ibrahim and Jurong Pier Rd on the left lane as the traffic light had turned green. However, there was a red car bearing registration number SLD8651E on the left lane of Jurong Pier Rd that did not give way to me despite it being my right of way. Subsequently, the front wheel of my vehicle collided against the right side of the car. Due to the impact, I was thrown off my motorcycle and landed on my left side. I broke my left arm and left leg along with some scratches on my right hand and left knee. I was informed by a passer-by that they have contacted Police and ambulance. I was conveyed by Ambulance to Ng Teng Fong General Hospital and received 15 days of MC from 14/09/2022 to 29/09/2022.
