


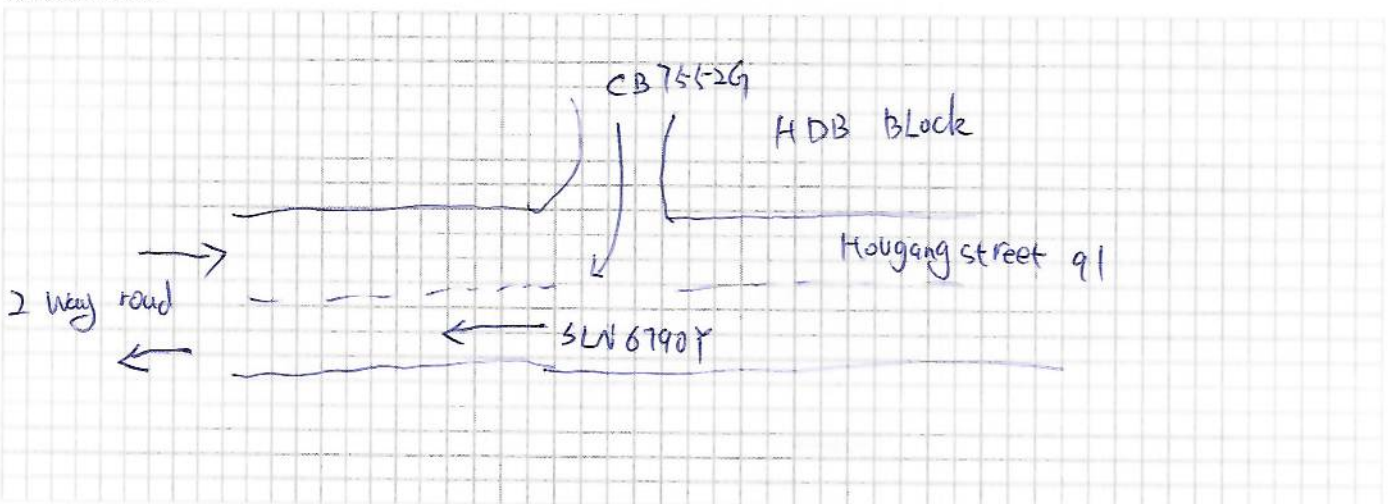

1. I (WeiHan, driver of SLN6790Y) was driving straightly along Hougang Street 91
2. After passing by the T-Junction near the small street exit from Blk915, the mini school bus (CB7552G) rushed out, and hit my car from the rear.
