I was at Tiong Bahru Rd when I received a job to pick up rider at Kim Tian. From the video, can clearly show that the road is clear and I was very cautious filtering. Every lane change, check on traffic and blindspot done with maximum precautions. I remembered very clearly that the involved vehicle SJR4259G was travelling extreme left without signal right on having the intention to make left turn which instigated me to carry on with the filtering. From the video, it clearly shows that I have successfully filtered to the second left lane and making a left turn is already possible. Video also shows that the involved vehicle is travelling fast and the right turn was a harsh one resulting to the incident. I would like to highlight that all the while my signal light is on. My intention of turning left is very obvious. The involved vehicle obviously is behind obviously can see my left signal light flashing. I don't understand why driver still Wana pick up speed to over take me making a harsh right turn resulting to the incident.

Incident happened Saturday night 20:50.

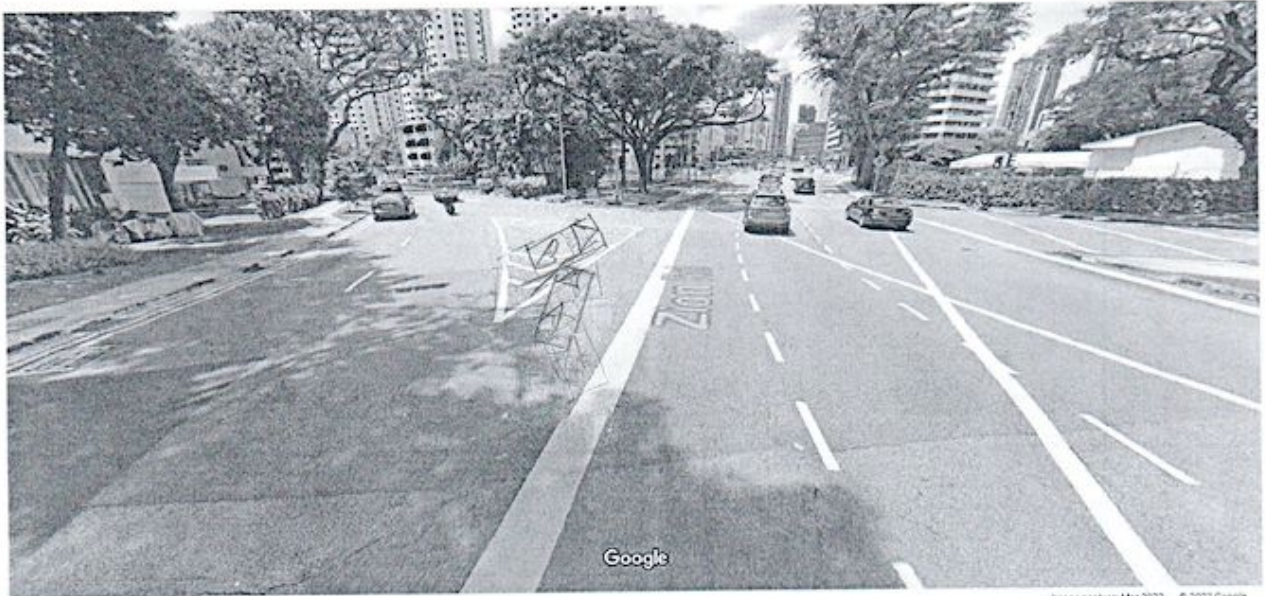

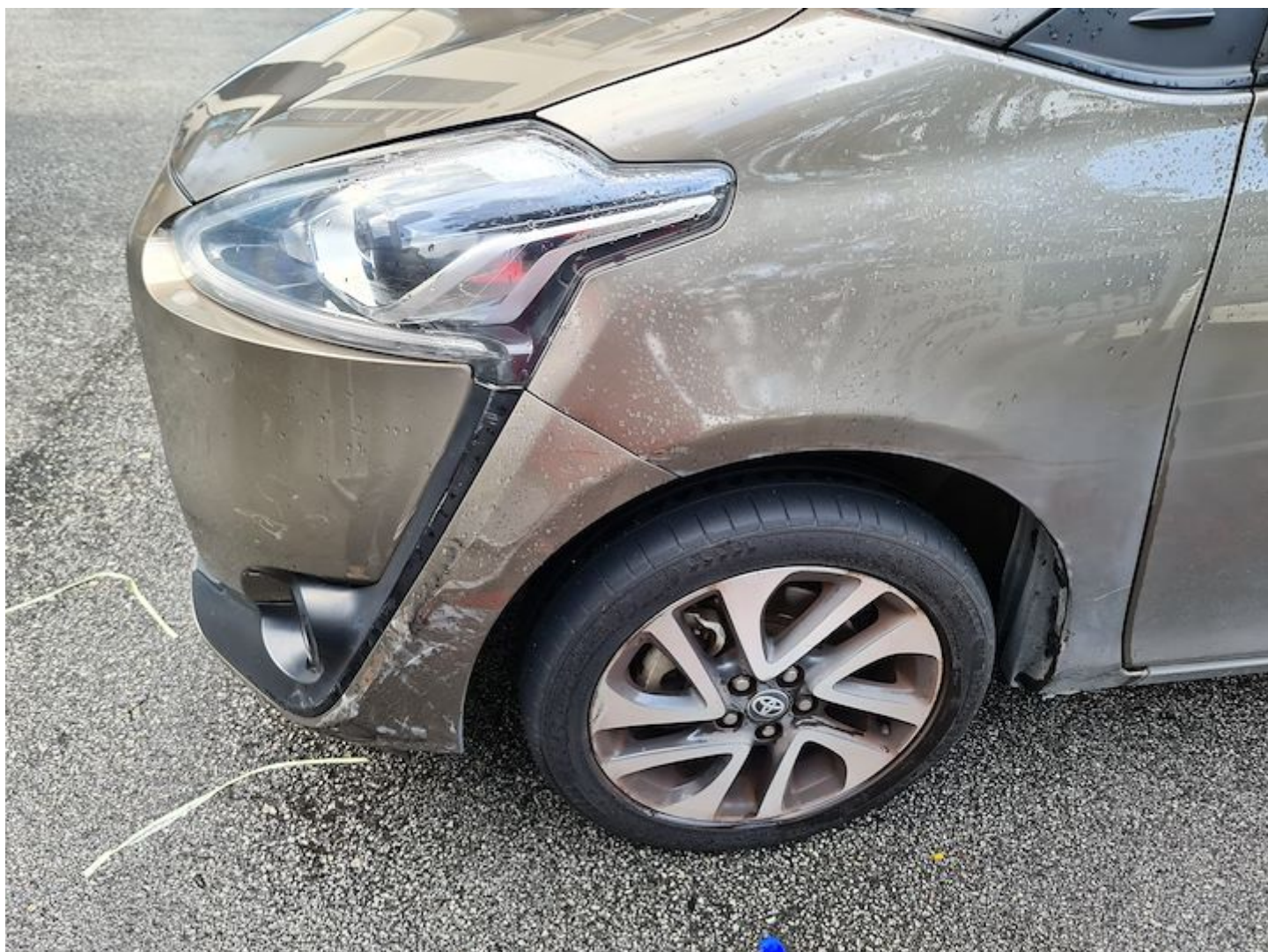
