


At around 9pm I was travelling along PIE towards Chaigns direction near Steven Rd east of 90 km/h. Suddenly at around noon away, I saw some vehicles stopped at Lane 1 of the highway and I applied brake to slow down.

I managed to stop in front of the stalled vehicles (actually there was another accident). I waited for about 5 sec before trying to ~~fit~~ filter to Lane 2 so that I can overtake the stalled vehicle. However before I can filter out, I heard a loud ~~sound~~ behind my vehicle and followed by another loud sound and felt my vehicle surged forward.

I quickly pressed the hazard light & ad alighted to check what happened. I saw a Merc A180, SM/538VZ hit onto the rear of my vehicle.
