

Brief Details.

On 24/9/2022 at about 0300hrs, I had parked my car along Syed Alwi Road at the parallel parking lot next to the Vagabond Hotel as I wanted to have my supper at the nearby eateries. Everything was intact, nothing was amiss.

On the same day at about 0345hrs, I had returned to my car and discovered that there were multiple long and large scratches and dents along the rear right of my car. I was approached by the hotel staff namely Benjamin - C/N: 90055870, who informed me earlier that the front left of a White BMW car had collided onto the rear right of my car. He informed that the white BMW had left immediately after colliding and did not stop.

I had called for the police afterwards and was attended by traffic police officer. Traffic Police had conducted their investigation and I had managed to speak to the driver of a car than was parked a short distance away behind my car. The owner of the car had an in car front facing camera that had recorded the incident and the owner had shared the footage with me. I had watched the footage and saw that a white BMW car was driving along a clear road with no oncoming traffic when the front left of the white BMW collided onto the rear right of my car. The BMW then immediately drove off.

I was given a police case card vide report number: A/20220924/0048 by the traffic police officer and was told to lodge a traffic accident report. As such, I am now lodging this report under the instruction from traffic police and for insurance claiming purposes. Benjamin, the hotel staff informed I could contact him by messaging through WhatsApp should I require any Witness.
