Brief Details.

On 21/06/2022 at about 1130hrs, I was tasked to load paper bundle at Angel Pte Ltd located 12 Bulim Avenue. On the said day, it was raining heavily and I was alone. When I was at the company loading and unloading bay, I had reversed my lorry bearing the registration number NCR8798 with my container bearing the registration number TN5224 slowly due to the visibilities issues. No one was guiding me to reverse at that point of time. While I was reversing, I suddenly felt an impact at the rear thus I stopped my lorry and went down to make a check. I later discovered that one of the zinc material wall panel top part had a slight dent. Thereafter, I load all the paper bundle in my container and subsequently left the premises. On 22/06/2022, my company, Tan Siah Pengangkutan Shd Bhd boss approached me and informed that he received a complain from Singapore Angel Pte Ltd stating that the vehicle I drove on 21/06/2022 had crashed against it's company wall. Subsequently, my boss show me the wall photo of the damage wall. To what I recalled on the said day, I only one panel of the wall was dented, however the picture of my boss shown displayed few panel dented. I informed my boss of the incident hence my boss advised me to lodge an accident report for insurance claims.
