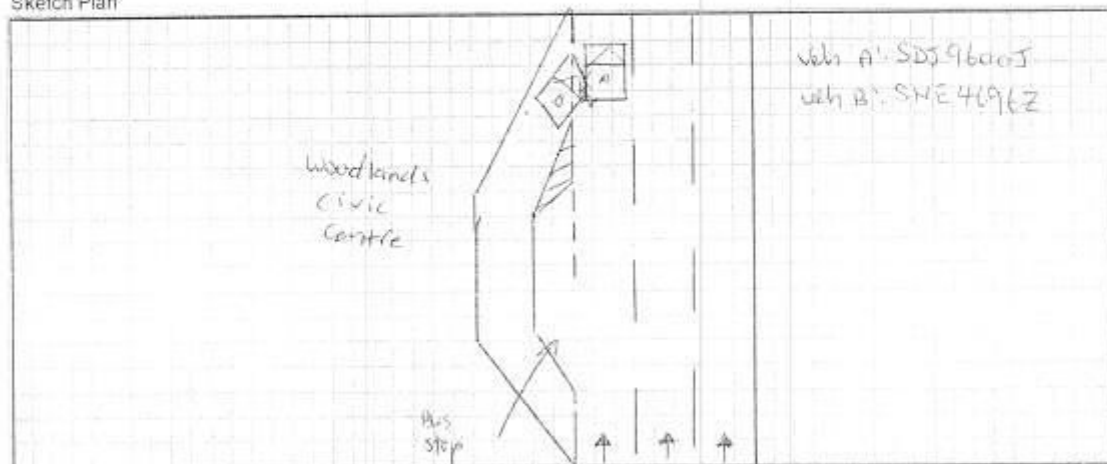

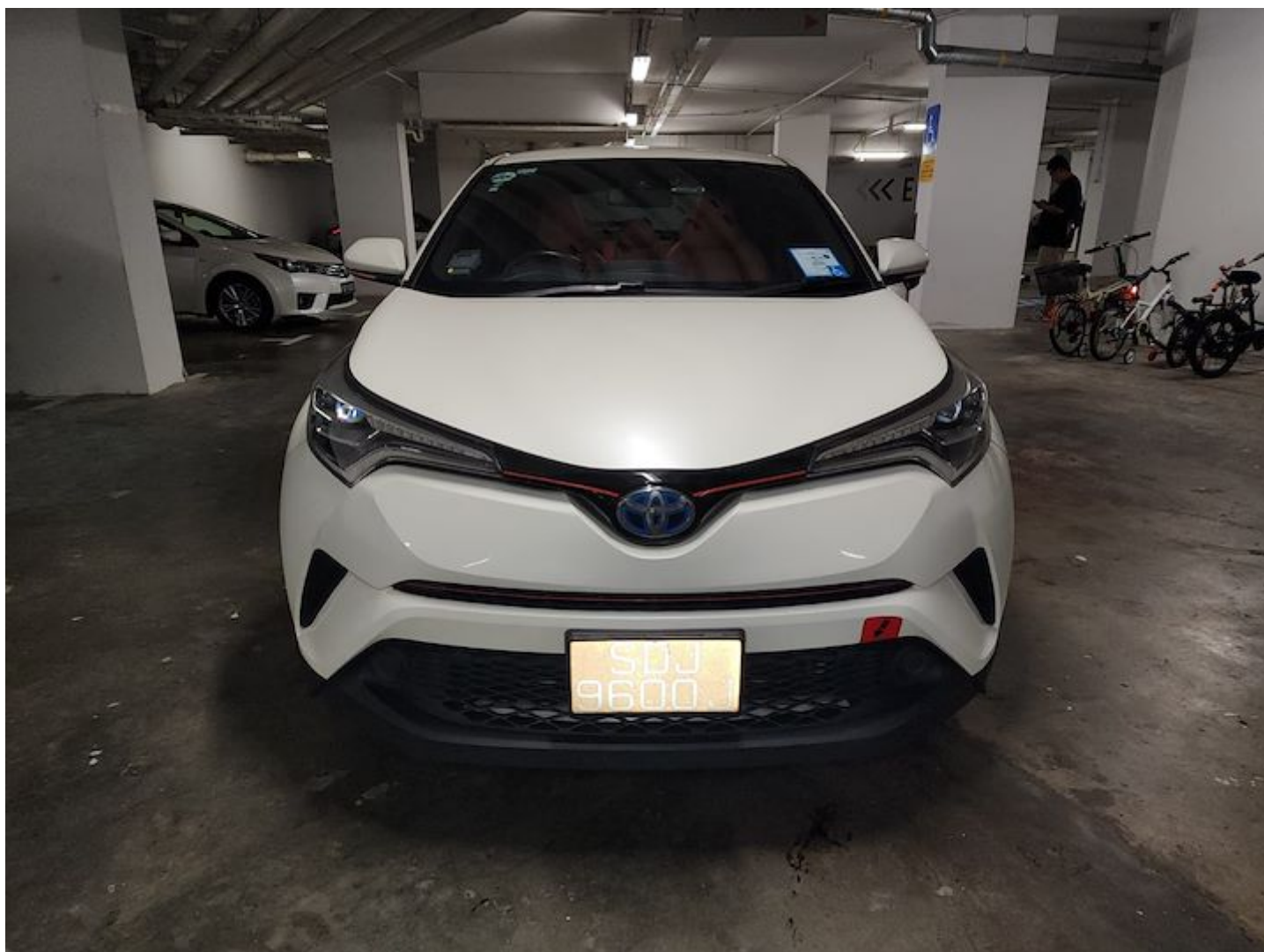

Brief Details:

After the incident I felt pain and discomfort and consulted a doctor and was given 5 days mc.
