ON 07/10/2022 AT ABOUT 1125HRS, I WAS DRIVING IN VEHICLE A ALONG YISHUN AVENUE 6 ON THE RIGHT LANE TOWARDS JUNCTION WITH YISHUN INDUSTRIAL STREET 1 TRAVELLING STRAIGHT. VEHICLE B KEPT TAILGATING VEHICLE A (SHA8755C) AND VEHICLE A DECIDED TO SLOW DOWN EVENTUALLY VEHICLE B (SKN9648T) COLLIDING INTO REAR OF VEHICLE A. MOMENTS LATER, VEHICLE B DRIVER ALIGHTED AND APPROACHED AGGRESSIVELY VEHICLE A AND OPENED VEHICLE A DRIVER DOOR. VEHICLE A DRIVER REACTED IN ATTEMPTED TO PUNCH BUT VEHICLE B DRIVER BACK OFF A FEW STEPS BACK. POLICE WAS ACTIVATED ON SCENE AND NO ACTION WAS TAKEN.

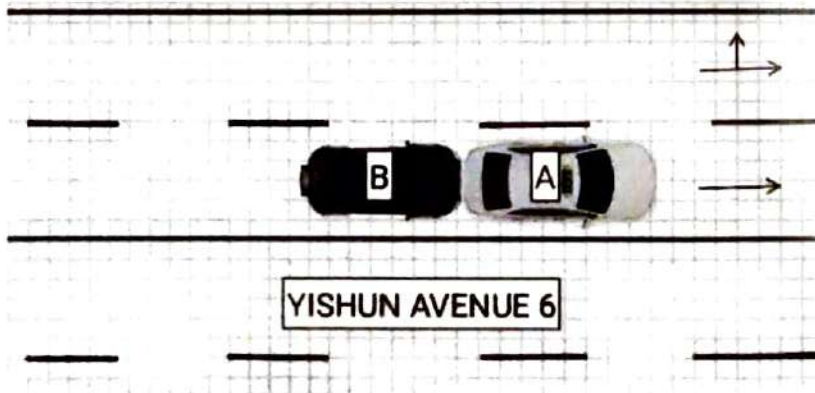
