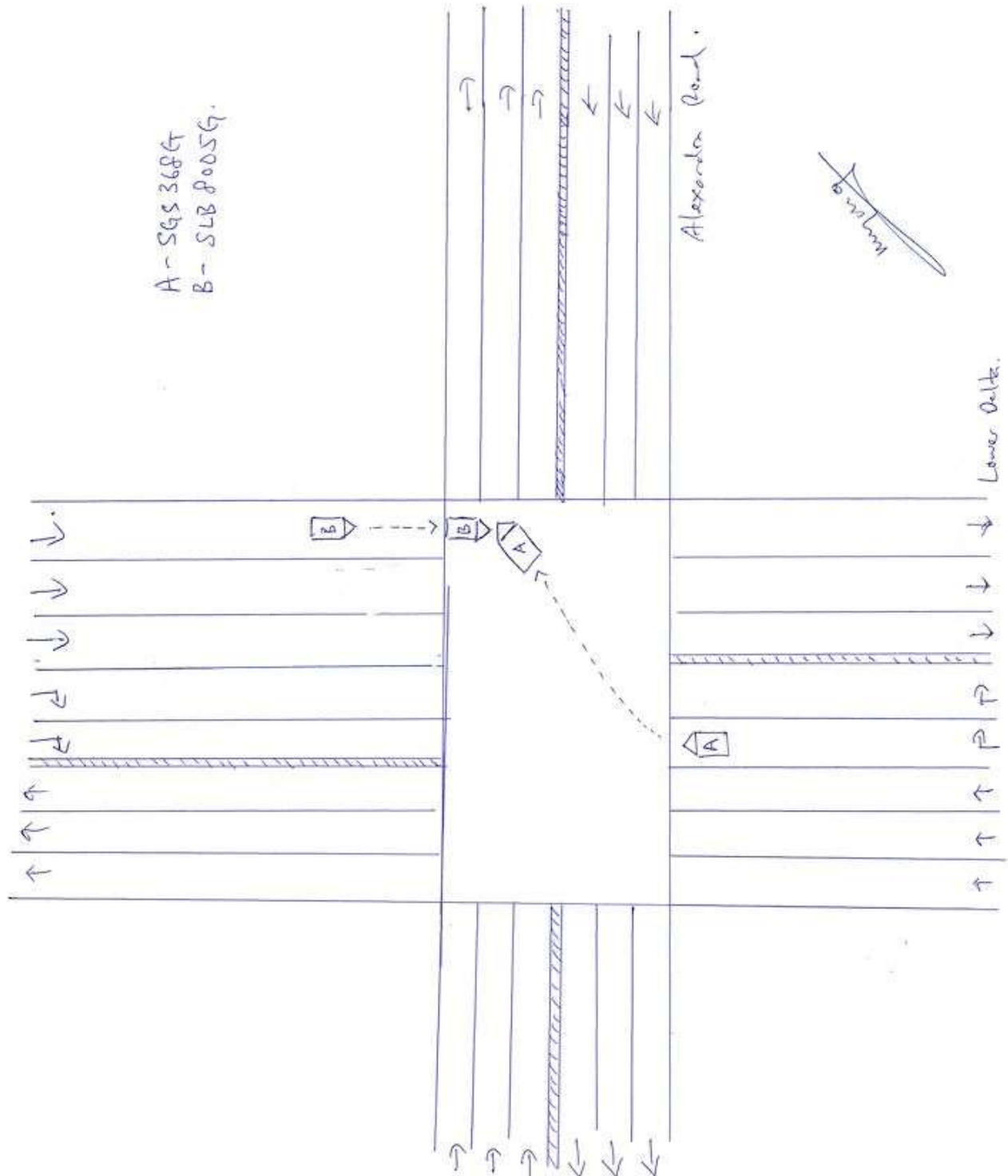

COMPOSITION OF REPORT

Brief Details.

On 05-10-2022 at about 0900hrs, I was driving my car (2015 Honda Civic) along the road. There was a car ahead of me with 02 more passengers in my car. I wanted to make a right turn onto Aljunied Road. The car in front of me in my lane and I moved forward into the right turn. As I was turning my car, a black car (2015 Honda Civic) hit onto the front left side of my car. The impact made me jerk forward and I lost control of the steering wheel. The 02 passengers in my car did not suffer any injuries.

I got out of my car and the other driver did too. We exchanged names and addresses. The other driver's car was damaged. There was no need to report the accident to the police and just go to "hospital". I can see the side of my car from the car. No police officers being sent to attend to my accident. The accident is my fault as I was turning left.

After the accident, I continued with my journey. However, as the car was damaged, I had to stop the car and call the police. I went to my GP for medical check-up. I also went to the hospital for my car. I went to my GP at 11:00 AM on 05-10-2022 to 11:00 AM 2022.
