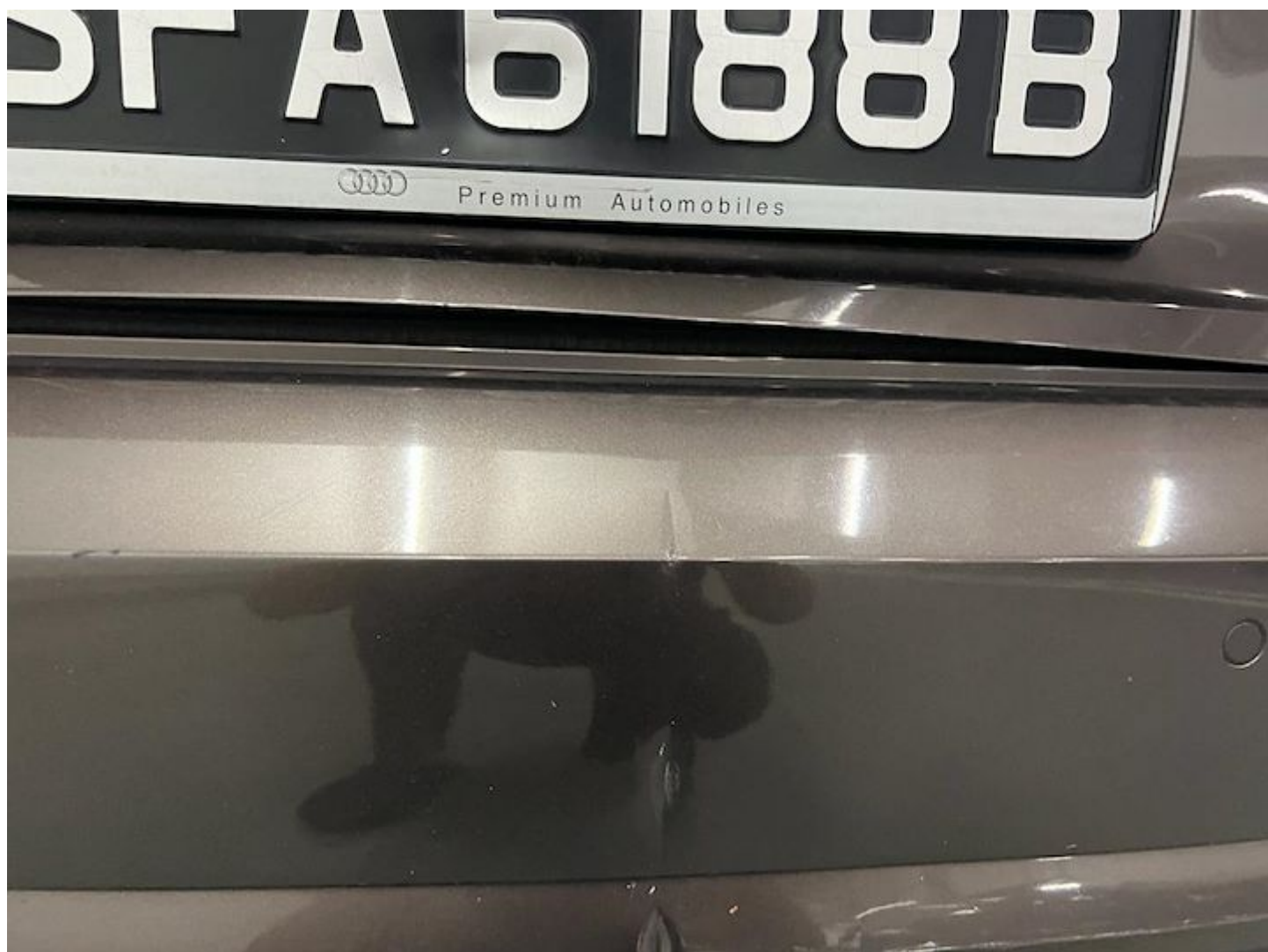












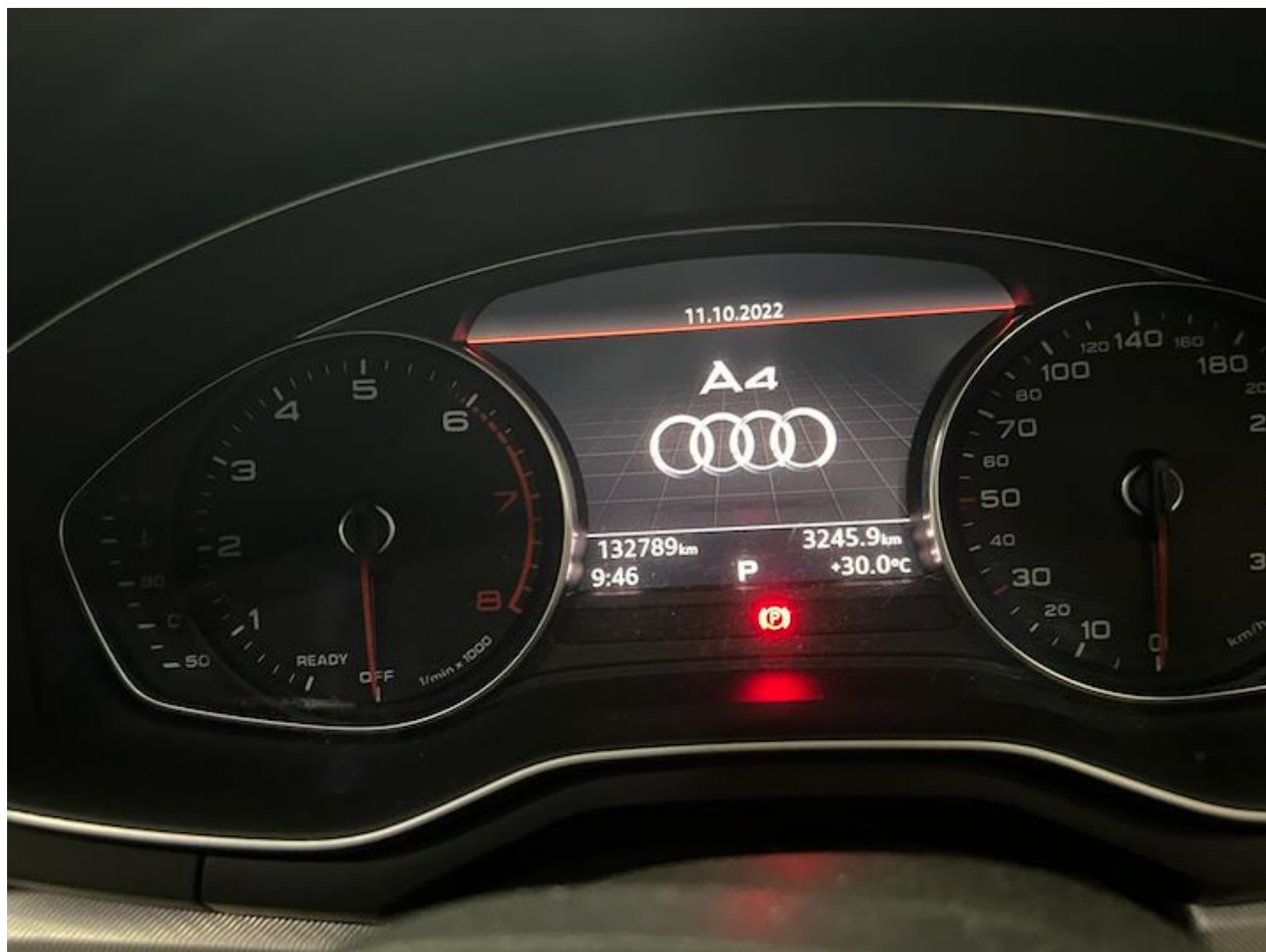

NOTICE OF REPORTING

This is to confirm that Chia Hock Hwa, NRIC/FIN S0301989F, has reported to the Police a non-injury traffic accident which occurred at Holland Rd towards Farrer Rd on 07/10/2022 at 1445hrs involving the following vehicles:

V1) SFA6188B (Informant)
V2) SMS6719P

Facts:

On the above-mentioned date, time and location, I was driving my car (V1) alone along Holland Rd towards Farrer Rd on the second lane from the left. As it was then beginning to rain, I drove slowly at about 60km/h.

Immediately, after passing the traffic lights nearest to Farrer Rd, V2 that was behind me, came crashing into the back of my vehicle. The impact of the crash onto the rear of my vehicle was so intense that my water bottle in the center compartment between the driver's and passenger seats was flunked out. The water bottle almost hit me was then bounced to the passenger seat and landed on the floor. The coins at the coin slot compartment were spilled all over the car as well.

I then steered my vehicle to the first lane from the left and turned on the hazard lights with the intention to stop. V2 driver followed and stopped behind me. We then exchanged particulars, survey the damages on our vehicle and discuss the following steps.

The damages to my vehicle are as follows:

1. Dent to my rear bumper (two sharp deep dent)
2. Car boots unable to close evenly
3. Tools area underneath my car boots were not inspected as the rains became heavier.

The damages to V2 are damaged on both left and right front signal light. There were no passengers in both V1 and V2. I have a in car camera, both front and back. However, I have yet to review the footage. No one was injured during the accident. No police or ambulance attended to us. No government property damaged as well.
