Received your notification and we spoke pm 28 Oct 22.

I had reported the accident through Mova Automotive Pte Ltd of 1008, Bukit Merah Lane 3, #01-04/06/08, S159722 on 11 Oct 22 and instructed them to make third party claim on the other car's AIG insurance. Dash- cam video recording also submitted. Though the statement given was brief, the other car, only 1 car park lot away swerve out of the lot side- swiping my car, sending my front car plate flying (can be seen in video). Clearly my car is ahead and stopped while the other car is exiting the lot at relatively high speed, turning left out of the lot, perhaps not seeing my car ahead of hers (while turning) side-swiping and only stopping a distance away after collision.

Please keep me informed on the progress of the case.
