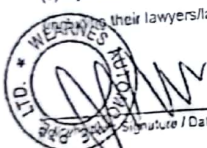

Brief Details.

On 05/10/2022 at about 0830hrs I was driving my van bearing registration plate number GBD5549G along AYE towards Tuas near to exit 17. I was driving on the extreme left lane. The traffic was slow moving. Suddenly, was hit from the back by a bus bearing registration plate number PD171D.

The impact was great. It caused me a great headache. I sat for a moment before alighting my vehicle to check. The front of the bus had hit the back of my vehicle.
