I am Paul Heffernan and I am a Senior Trackside Engineer working for Formula 1. I have been working for Formula 1 for 24 years since 1998. I have worked in Singapore in this capacity since 2008. I have a full UK Driving License which I have held for 29 years, and I am qualified to drive numerous classes of vehicles the heaviest of which is European Class C1E

My primary role for Formula 1 involves installing onboard camera and on car received systems which necessitate me to install various technical equipment at the side of the track.

As this is a night road race, the work I do necessitate me using the highway. Whenever we are engaged in installations, we set up a traffic management system using cones and traffic direction signs to signal to other road users that we are stationary and carrying out work. This work complies with Formula 1 Health & Safety requirements and method statement. This installation process is tried and tested, and I have never had any issues with this activity in Singapore previously.

About 1330hrs on Tuesday 27th September 2022 together with Mike Strutton I left the Formula 1 compound. At that time, I was driving a white Toyota pickup truck registration number YQ8148U heading out to begin installation of equipment. Mike and I carried out several installations that day round the track in line with standard operating procedures for this activity.

About 1620hrs that afternoon, we had just completed installation at the intersection of Nichol Highway and Raffles Avenue and both Mike and I were sat in the truck. I was driving. We had just recovered the traffic management equipment and intending to

someone had collided with the back of the truck. I remember Paul saying something like "He has gone into the back of me". We carried on a short distance to look for somewhere safe to pull over. Paul pulled the truck over – I cannot remember the name of the road we were on. Paul got out of the vehicle and approach the driver of the other vehicle that had pulled up behind us. I overheard a conversation where the driver of the other vehicle said something like "how are we going to sort this out" he mentioned something about a cash payment and Paul said something about having to go through Insurance companies. I saw Paul and the other driver exchange some details. While Paul and the driver were talking, I took some images of the damage to the vehicles using my personal mobile phone. Both Paul and the other driver took images of the damage with their mobile phones and then Paul and I got back into the van and started to make our way to the next installation.

As we pulled back onto the highway, I could hear a loud vehicle coming up behind us, this vehicle undertook us on my side (which may have been a bus lane), and it was at that point I noticed that this was the vehicle that had collided with us.

The vehicle involved in the collision was a red-coloured Audi S3. I think I would recognised the driver again if I saw him.

At the time of the collision the road surface was dry, the visibility was good, and the traffic flow was steady.

My primary role for Formula 1 involves installing onboard camera and on car received systems which necessitate me to install various technical equipment at the side of the track.

As this is a night road race, the work I do necessitate me using the highway. Whenever we are engaged in installations, we set up a traffic management system using cones and traffic direction signs to signal to other road users that we are stationary and carrying out work. This work complies with Formula 1 Health & Safety requirements and method statement.

About 1330hrs on Tuesday 27th September 2022 together with Paul Heffernan I left the Formula 1 compound. At that time, I the front seat passenger in a white Toyota pickup truck registration number YQ8148U heading out to begin installation of equipment. Paul and I carried out several installations that day round the track in line with standard operating procedures for this activity.

About 1620hrs that afternoon, we had just completed installation at the intersection of Nichol Highway and Raffles Avenue. We had just recovered the traffic management equipment and intending to drive to our next installation point. At that time, we were in the nearside lane (lane 1) of the operational lanes on the highway. We needed to move out into lane 2. I think at that time I was looking at the track drawing to see where our next installation was. As we moved into lane 2 I felt a sudden jolt at the back of the truck and heard some sort of noise and I formed the impression that

drive to our next installation point on Stamford Road. At that time, I was in the nearside lane (lane 1) of the operational lanes on the highway. I was intending to move from lane 1 into lane 2 to turn right onto Stamford Road. Before setting off I checked my mirrors to ensure that the road was clear. At that time the highway was relatively busy, so I needed to wait for a short time before setting off. When the road was clear I again checked my mirrors and activated my right-side indicator. At that time, I could not see anything behind me, so I began to pull across into lane 2. I had just carried out the maneuver into lane 2 and was proceeding towards Stamford Road when I heard a loud horn noise which I could tell was coming from behind me. Immediately after I heard the noise, I felt something collide with the rear offside of the van. At that time, I would estimate that I was travelling about 10-15mph. The collision was big enough for me to feel and to have to recorrect my steering due to the contact. I immediately looked in my nearside mirror and saw a red car behind me which was clearly the car which had just collided with our vehicle. I continued cautiously around the bend onto Stamford Road where I pulled over into the near side lane (lane 1). The red car pulled up behind me.

Mike and I alighted from the truck as did the driver of the red car. We walked towards each other, and the driver of the red car said to me "WHAT THE FUCK". I replied, "YOU HAVE HIT ME". I asked him if him if he was OK, and he said yes. He asked me if I was OK, and I said yes. The driver then said words to the effect that he was OK, but his car was not. The driver of the red vehicle said something like WHAT DO YOU WANT TO DO ABOUT THIS NO?. I told him that we should exchange details and that I would report the collision to 'my company' and he should let his insurance company know.
