Brief Details.

On 12/10/2022 at around 0830hrs, I was travelling along Woodlands Centre Road near to the Woodlands Train Checkpoint bus stop, one vehicle (SHD6105B) collided to the rear of my vehicle. It is heavy traffic at that point of time and the traffic light turn green however I am unable to move due to the heavy traffic volume at the Woodlands Checkpoint Taxi stand area. When I am moving off, I suddenly felt an impact on the rear of my vehicle and I noticed that the said vehicle (SHD6105B) collided to the rear of vehicle. During the accident, I injured my neck due to the impact. I have yet to visit a doctor to make a check.

I then noticed that the rear bumper was badly dented and I observed that the front part of the said vehicle (SHD6105B) was slightly dented. He is also not injured. We then exchanged our particulars and subsequently went off.

I will be making a check on my injury with the doctor after I lodge the report. There is in car camera in my vehicle however it is not working.
