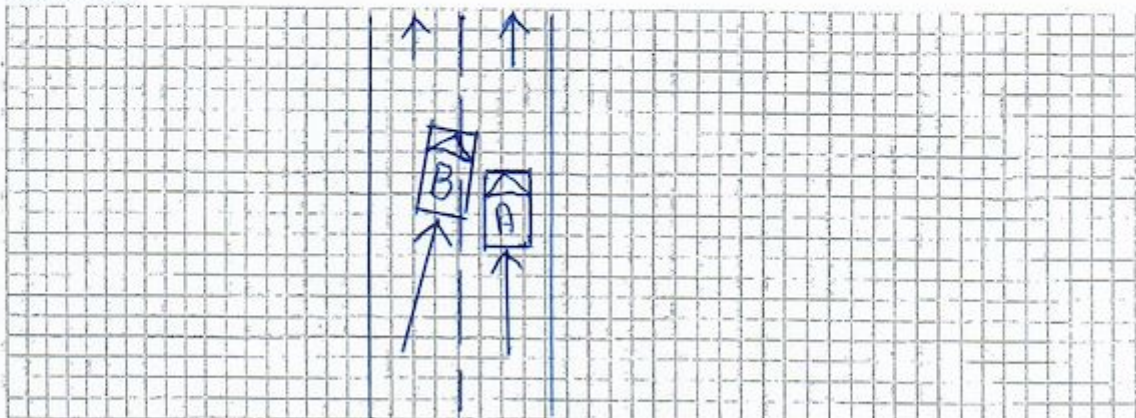

Sketch Plan


