

Brief Details.

On 10/10/2022 at about 2305hrs, I was travelling in my vehicle bearing registration plate number SMD2327U along Punggol Road towards the X-junction of Punggol road and Rivervale Drive. As I was turning right into Rivervale Drive, I slowed down as it was a discretionary right turn. However, the vehicle in front of me bearing registration plate number SMY4956E, who was also turning right into Rivervale Drive did not slow down and give way to oncoming traffic. As a result, the front of the said vehicle collided onto the right rear side of an oncoming lorry bearing registration plate number GBA9338M. As a result of the collision, the said lorry swerved and mounted the kerb and rammed through the divider. The green divider then hit onto the rear right side of my vehicle.

There were scratches and dents on the rear right side of my vehicle. Ambulance and Traffic Police was also at scene. I wish to state that I feel pain on my right shoulder, neck and lower back however have not been medically assessed.

I have an in-car camera installed which captured the footage of the accident.
