Brief Details.

I am lodging this report because there are some error in the previous report vide T/20221011/2014 dated on 11/10/2022.

On 10/10/2022 at about 0910hrs, I was riding my motorcycle(FBS6833A) along PIE near to KPE(exit) at the right most lane after which, one lorry(GBJ6960M) on my left(second right most lane) skidded and merge into my lane and collided into my motorcycle. Due to the impact, I collided into the railing on my right side.

I called for ambulance and was later conveyed to Raffles hospital for medical attention. I was also given 4 days of MC. I recalled there was traffic police at scene after I called for ambulance. I am not able to provide the incident number because I was conveyed.
