ON 13/10/2022 AT ABOUT 1230HRS, I was driving vehicle A along Cairnhill Road towards Orchard road. I am on Lane 3 waiting for green light. When it's green, I proceed as normal negotiating the left turn into Orchard Road. I position myself into lane 3 of 5 lanes on Orchard road following the road markings.

Suddenly a vehicle B came from my left during the completion of my left turn and he turned into lane 3 of Orchard road disregarding the traffic law.

I only managed to sound the horn and apply brakes but it was too late to avoid the accident.

And he stopped on lane 3 of Orchard road and I drove up next to vehicle B and signaling him to exchange particulars at Center Point.

Meantime I check on my passenger on her well-being and she claim she wasn't injured.

I slowly creep my vehicle forward to Center Point and exchange particulars with the driver.

As I am obstructing traffic at Center point I drive the vehicle to Kramat Lane & arrange for tow truck.

While waiting for the tow truck I did vomit at a toilet.

Tow truck brought me and the vehicle to reporting center.

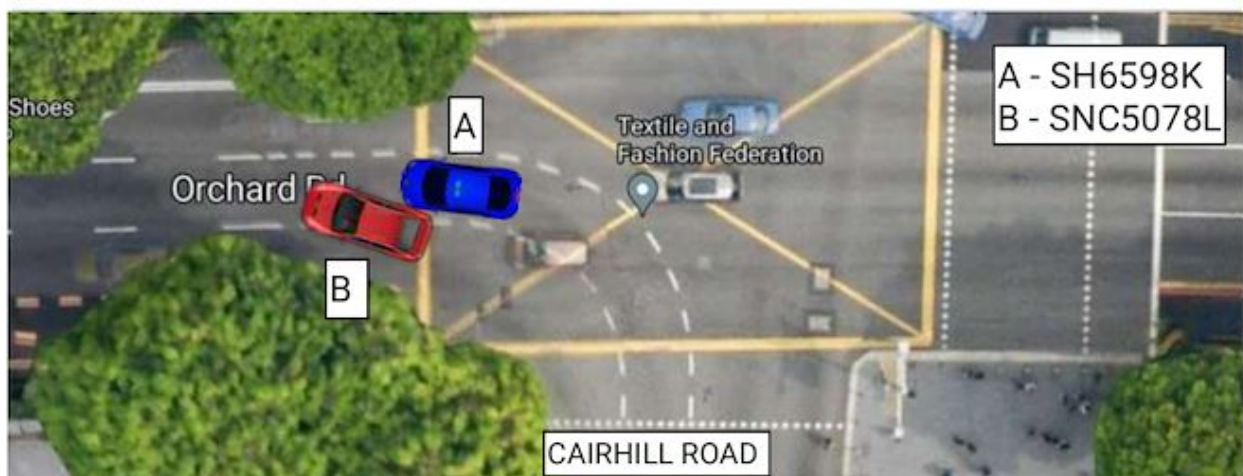
