Young and Inexperienced Driver: Additional S\$ 3,000.00 (Below 26 yrs old and driving experience of 2 yrs and below)

- Hirer is liable for any loss of, or any damage which include physical damage or any other general damages to the vehicle
 and its accessories during the rental period, the Hirer must make payment of such repair or replacement cost immediately.
- 8. The Hirer has to return the vehicle with the fuel at the same level as when collected the vehicle on (Date Out).
- The Owner will not be responsible for any loss of or damage to personal belongings in the vehicle during rental period and after returning the vehicle.
