ACCIDENT INVOLVING SJY1726H (ALLIANZ) AND SMA492D AT/ALONG 16 JOO SENG ROAD ON 14/10/2022

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, Allianz Insurance Singapore Pte. Ltd to deal with the third party claim against your policy.

We have received a claim from **SMA492D** against your insurance policy.

Based on the accident report, accident scenario and Traffic Police Investigation Result (enclosed) received by third party, we are of the view that liability is not in your driver's favour.
