Additional all claims excess of \$0.00 applies for any unnamed Z10/Z11 driver not listed in the Schedule.

**Additional Excess Applicable for Social, Domestic &/or Pleasure usage**

Additional Own Damage Excess of \$500 applies for any unnamed driver not listed in the schedule. For unnamed driver below 27 years old and/or with less than 2 years of relevant driving experience in Singapore, the additional excess applicable shall be further increased by \$1,500.

**Additional Exclusion Clause**

The Company shall not be liable in respect of any accident loss damage or liability caused sustained or incurred out of the ownership, operation, maintenance or use of any vehicles the principal use of which is:

1. The transportation of high explosives, such as nitroglycerine, dynamite or any other similar explosive;
  2. Bulk transportation of liquefied petroleum or gasoline;
  3. The transportation of chemicals or gases in liquid, compressed or gaseous form;
  4. The transportation of hazardous waste.
