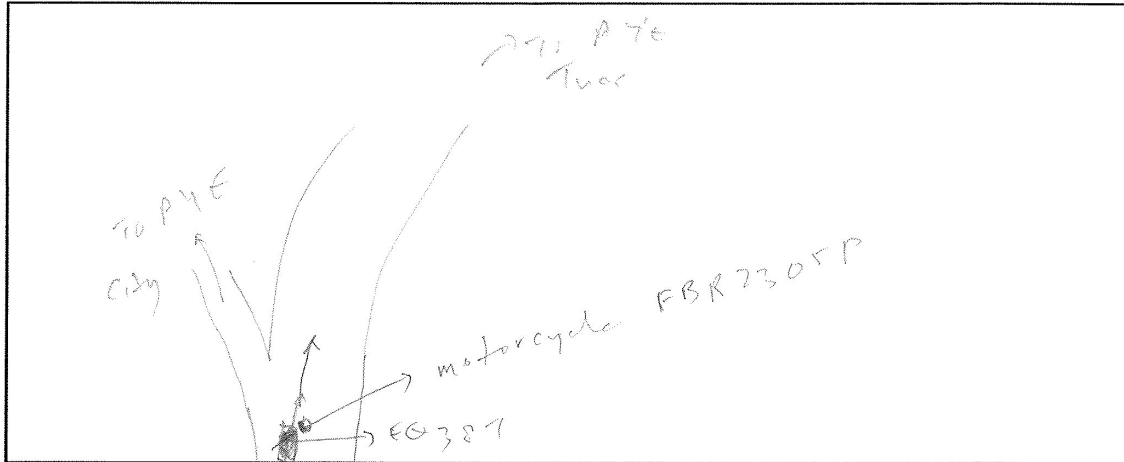

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 29/12/20 at around 2003 h, I made a U-turn at the junction of Clementi Ave 6 and Commonwealth Ave West. I was heading for the AYE Thas, keeping to the right lane.
I turned on my indicator indicating turning right and was filtering towards to AYE Thas in the right lane.
I was already on the lane leading to AYE Thas when a motorcycle FBR2305P ridden by Mr. Benjamin Yeo overtook me on my right. His rear portion of the motorcycle grazed my right fender. He did not fall.
We both stopped. He appeared perfectly well and his pillion rider complained of left ankle pain. His ankle was not swollen or bleeding and had a full range of motion.
His motorcycle (Honda NC700) suffered damage to the left foot rest for the pillion rider. My car had not scratches and a slight dent on its right front fender.

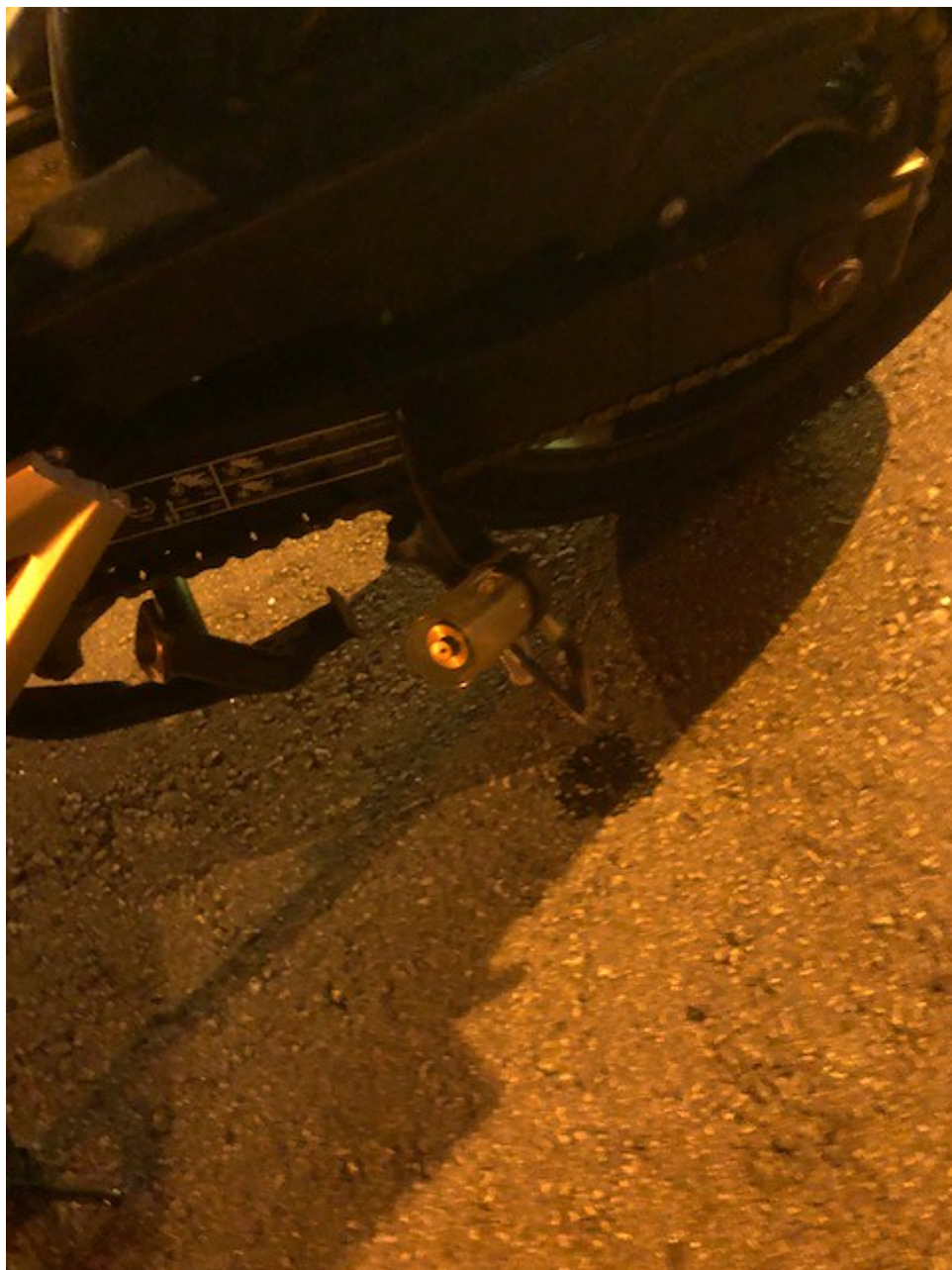
