We refer to the above and to your adjustment report dated 22 November 2022.

We have met with our clients' insured driver, who alleges that there were pre-existing damages to the Claimant's vehicle in the form of black marks at the bottom portion of the right rear passenger door. Our clients' insured driver claims that these could not have been caused by his vehicle, which was blue in colour and pointed us to blue marks made to the Claimant's vehicle as evidence that any impact would have only left blue marks.

We had previously sent you the video footages from both parties' vehicles and their respective GIA reports. Kindly peruse the same and let us have your opinion on whether the black marks to the Claimant's vehicle are likely to be pre-existing / inconsistent or if they were caused by the material collision. In the event that the former is more likely, please let us have your revised RI report as well.
