





Brief Details.

I was driving on Tampines Rd towards Upp Serangoon Rd at the Hougang AVE 1 junction. The front car had barely crossed the road line when the lights turned to amber. He then jammed his brakes to stop for the traffic light. I continued moving ahead as I was too late to stop for the traffic lights and I assumed he would continue to drive on.

When he jammed his brakes, I also jammed my brakes. However, my car didn't slow down fast enough and I rear-ended him.

He had his wife and child onboard. None of them were reported to be harmed at the site of the incident.

I was with my 29 week pregnant wife (who was sitting at the front passenger seat. We were both buckled into our seatbelt and the airbag was deployed upon impact.

A passerby, Steve (phone number 98222622), assisted in calling for an ambulance and my wife and I were sent via ambulance to SGH for observation and treatment.

I have been discharged at about 10am. Diagnosis was a right foot sprain. My wife is still under observation at SGH and awaiting diagnosis from doctors. No notable injury to mother and baby thus far.
