Sketch Plan

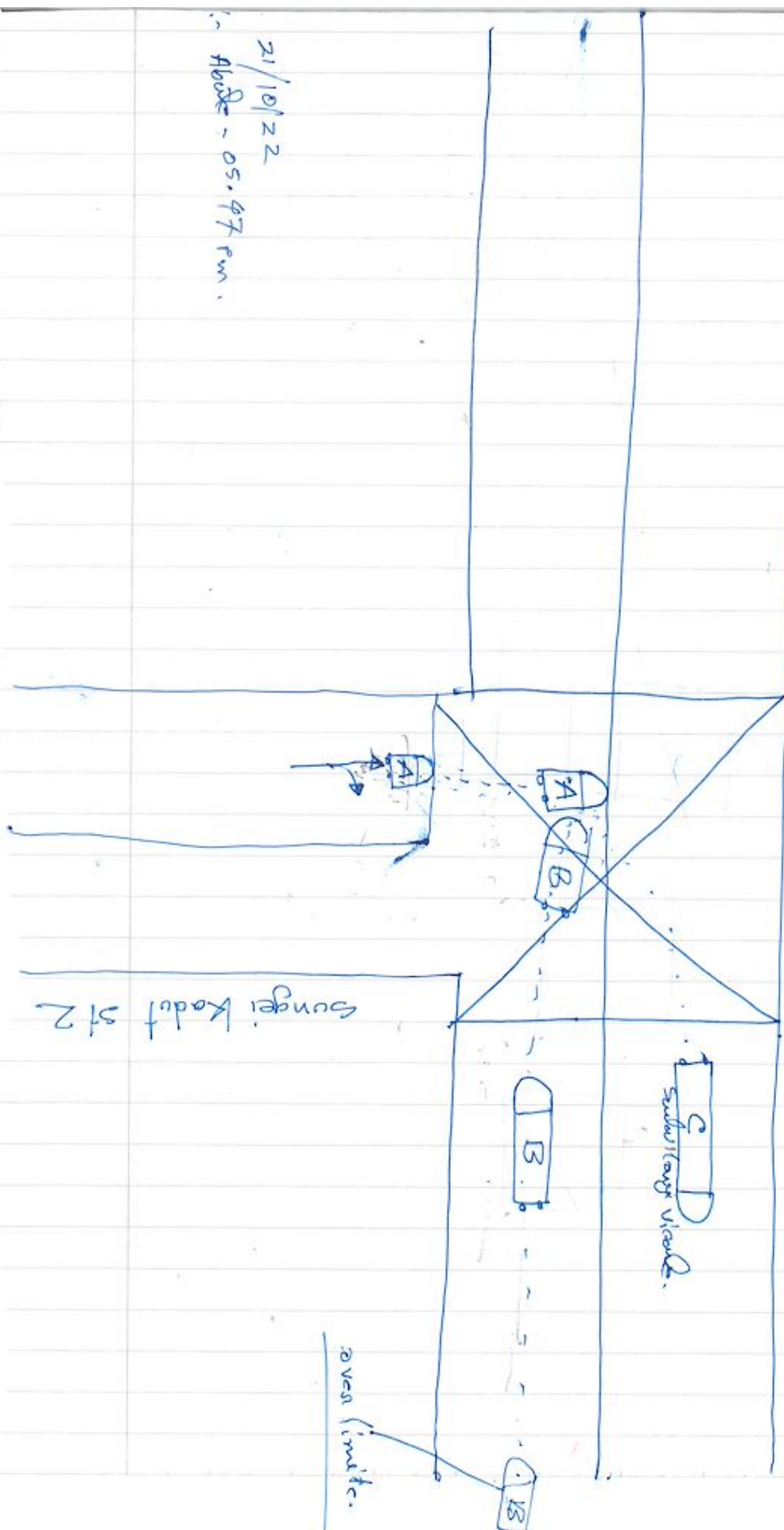
