TRAFFIC LIGHT WAS GREEN IN MY FAVOUR AS I PROCEEDED STRAIGHT. SUDDENLY, VEHICLE NUMBER - SJU5572D, TURNED FROM THE OPPOSITE DIRECTION TO PASIR RIS WALK AND COLLIDED ONTO MY VEHICLE'S FRONT PORTION. THE SAID VEHICLE THEN MOUNTED THE KERB ON THE LEFT.
