Brief Details.

On 18/10/2022 at about 1915hrs, I was riding my motorcycle, bearing registration number JUA 5367, on the 2nd lane of along PIE towards Jurong, near exit 12. At that time, the 1st lane was congested with cars.

Suddenly, a car from the 1st lane abruptly changed lane to the 2nd lane without indicating his signal light. I could not brake in time and as a result, my motorcycle collided onto the car's left side. I then fell to the ground. I stood up and walked to the side of the road. The driver disembarked his vehicle and approached me. I made a check and discovered that my motorcycle sustained damages on its front and its engine while the car sustained dents and scratches on its left side.

Another road user stopped by and assisted to call for the police and the ambulance and shortly after, they arrived at scene. I was conveyed to Tan Tock Seng Hospital and was only discharged the next day. I received a total of 5 days MC. I suffered a fracture on my left arm and some abrasions on both of my arms and right leg.

I wish to state that I have made a traffic accident report before with regards to this incident, reference: T/20221020/2013. However, the details of the vehicle involved was incorrect. Thus, I am lodging this report. I would like to add that I recall the driver of the car is a Male Chinese Singaporean.
