Dear Ezlyna,

Thank you for the call earlier today.

We refer to the email vide below by LKK Auto Consultants Pte Ltd ("**LKK**") on 14 November 2022.

We summarise the salient points of our discussions over the call as follows:

1. We wish to dispute the liability and by the same token, the grounds underpinning the liability of the accident.
2. LKK has kindly agreed to hold on the settlement negotiations with the claimant pending discussions between the insured and China Taiping Insurance (Singapore) Pte Ltd (the "**Insurer**").

Point 1 will be pursued separately by engaging the Insurer and any updates will be duly forwarded to LKK at appropriate junctures as may be determined by us or the Insurer.

Separately, we look forward to hearing more from you when the senior staff mentioned is back.

ACCIDENT INVOLVING SJG746B (CHINA TAIPING) AND SMM7489E AT/ALONG PIE TOWARDS TUAS BEFORE EXIT 36 ON 28/10/2022

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, China Taiping Insurance (Singapore) Pte Ltd to deal with the third party claim against your policy.

We have received a claim from SMM7489E against your motor insurance policy.

Based on the accident report and accident scenario, we are of the view that liability is not in your driver's favour. Therefore, we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
