



Describe Circumstance of the Accident





**Brief Details.**

The other vehicle licence plate number is SLJ3972E.


I came out of the car to check the damages and the other driver said it was my fault for not seeing him. He said that I should see him, not the other way round. I decided not to speak further and told him that I will be calling the police as his breath smell of alcohol. I called the police hotline 999 thereafter. I wish to state that the other driver was driving very fast.

Traffic police came and I told the officer what had happened. The other driver was subsequently arrested for drink driving. He had also given me a case card and advised me to lodge a police report.

The whole incident was recorded on my dashcam. My friend Sophia also saw the whole incident. During the incident, my girlfriend Wan Ling was inside the vehicle. No one suffered any injuries however me and my girlfriend feel some discomfort at our neck area.
