## Brief Details.

ON 31-10-2022 AT ABOUT 1900HRS, I WAS DRIVING MY VEHICLE BEARING VEHICLE NO. SLN 3006Z. I WAS TRAVELLING ALONG CTE. SUDDENLY, THE FRONT TRAFFIC SLOWED DOWN AND STOPPED, I MANAGED TO STOP MY CAR IN TIME. SHORTLY, I FELT AN IMPACT. THE VEHICLE (SHB 4070R) COLLIDED ONTO THE REAR PORTION OF MY VEHICLE, THE IMPACT FROM THE BACK CAUSED MY VEHICLE TO SURGE FORWARD AND COLLIDED INTO THE VEHICLE IN FRONT OF ME. I WAS INVOLVED IN A 3 CAR CHAIN-COLLISION.

I FELT PAIN IN THE HEAD RIGHT AFTER THE ACCIDENT AND SHORTLY AFTER I REACHED HOME, MY NECK, SHOULDERS, AND MID BACK STARTED TO FEEL DISCOMFORT AND PAIN, I HAD TROUBLES SLEEPING AND HAD HEADACHES IN THE WEE HOURS, I SEEK MEDICAL ATTENTION FROM A LIFE CLINIC PTE LTD ON 01-NOV-2022 MORNING AND RECEIVED 7 DAYS MC FROM 01-NOV-2022 TO 07-NOV-2022.
