

Brief details.

On 21st October 2022, at about 1935hrs , myself, Name: Abdul Haffiz Bin Abdul Aleem, NRIC: S8701277H was riding motorcycle Yamaha R6S 2007 of plate FBB7707P along Bartley Road East (Behind Bedok Reservoir) on the way home from Alkaff Mosque after my evening prayers when I notice there was a trail of smoke from the front left of my motorcycle.

I quickly take a peep to the left and notice there was a small fire at the lower left fairing of my radiator. I

quickly stop the bike by the roadside, switch off the engine and move the bike to the traffic light stop of Bartley Road East and Bedok North Road. I tried to fan the fire by damping the fire with a dry cloth to prevent it from spreading. The fire intensify and later on, a bangla worker drop down from a lorry with number YPXXXX(I cant remember as I was in a state of shock) with a dry powder fire extinguisher to extinguish the flame.

The fire was extinguish but the left and right fairing is burnt, together with the wire harness of my motorcycle, FBB7707P.

The whole incident ended at 21st October 2022, at about 1950hrs

Weather was clear at the point of incident and traffic was light. No damages to surrounding nor passer at the point of incident. I was no injured as well except that my right shoe has a burnt mark as a result.

I will be sending the bike to Ban Hock Hin motorcycle workshop at 6 Defu Lane 4 for repairs thereafter to make it road worthy again.

This is my first time in driving history of 16 years an incident like this happen and I was shocked and lost as I was not prepared.
