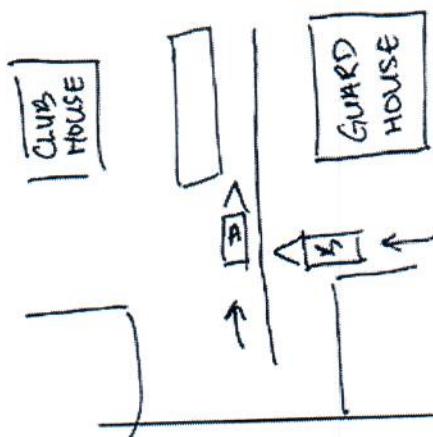

Sketch of accident scene:

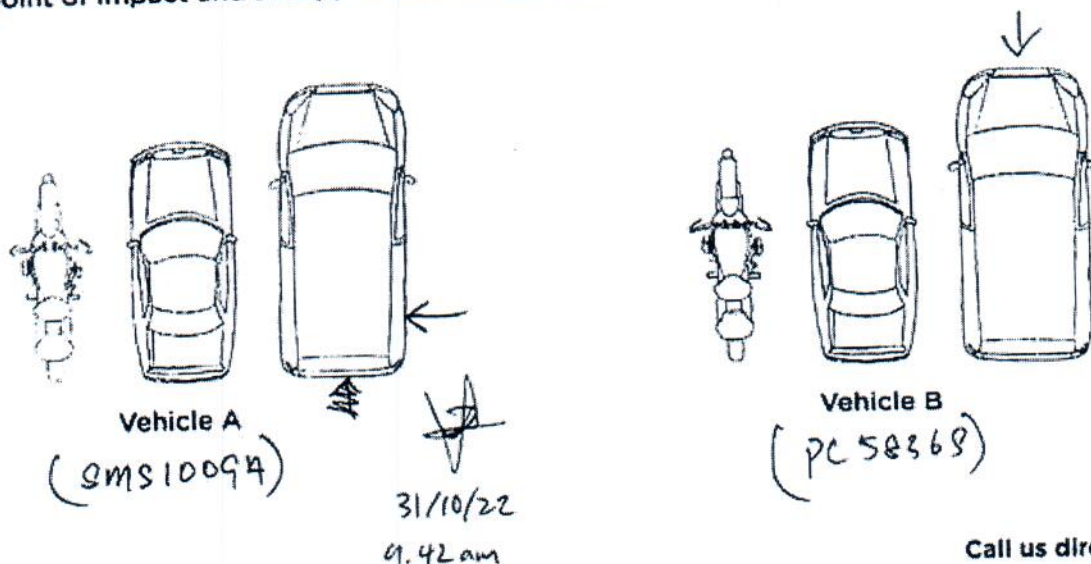
