Brief Details.

I am Khairi Bin Omar, NRIC S7219372E, DOB 06/06/1972 residing at Block 162B Rivervale Crescent #07 -218 Singapore 542162. Contact number 96544494.

On 03/11/2022 at about 0750hrs, I was driving my taxi bearing the registration number SHD4590X along AYE towards TUAS just after exit 11 when I encountered an accident.

I wish to inform that at that point in time, the traffic was heavy and it was drizzling slightly and the road was wet. I also had a passenger seated in the rear seat in my taxi. Whilst I was travelling on the extreme right lane of the expressway, the vehicle in front of mine had brake and stopped and I followed suit and my vehicle also came to a complete stop.

Suddenly, I felt an impact coming from the rear portion of my vehicle and I then realized that another car had actually collided into the rear portion of my vehicle. I wish to inform that I did not collide into any other vehicles at the said location. I went out to make a check on and discovered that there is damages to the rear portion of my vehicle due to the collision. The registration number of the vehicle that collided into mine is SMM2259K, a blue colored Honda. My passenger, a male Indian subject also informed me that he is alright at the accident scene. I

I had taken photos of the accident scene at that point and had exchanged contact with the other driver namely Kenneth, 92775828.

On the same day, I had gone to the clinic at 829 Tampines Street 81 #01-292 Singapore 520829 to make a check as I felt pain from the accident. I wish to inform that I am given 5 day Medical leave by the Doctor from 03/11/2022 to 07/11/2022 with the medical certificate number OD-TP0000449446.

I have lodge a report with the Taxi company and the cost of the damages is yet to be determined. As of now, I am unable to work during the period of my Medical leave and have a loss of income. That is all.
