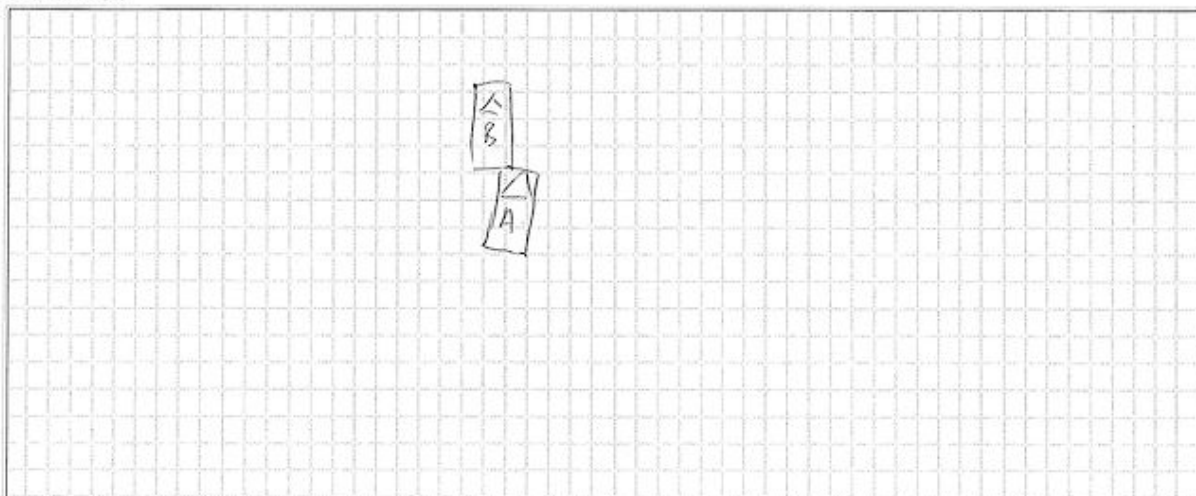

I, Chen Keng Nam (IC# S2005960E), would like to report a car accident that occurred at approximately 2.17pm on the 6th Nov 2022 (Sunday).

It was a cloudy afternoon with a light drizzle.

I was driving home with my wife. We progressed slowly and smoothly along Hougang Ave 3 in the direction towards Paya Lebar. All of a sudden, the van in front of our vehicle stopped unexpectedly. I reflexively braked immediately and steered to right to avoid a collision. Unfortunately, our car hit the rear right corner of the van.

Note: The site of the accident is along Hougang Ave 3 a few meters away from the traffic junction with Tampines Road. Pictures of accident are attached.

The van driver and I reviewed the damage and agreed to report it to insurance.

The damage to the van is minimal as it collided with a reinforced corner of the van. However, my left car lamps were severely damaged. After consulting with the BudgetDirect Insurance Hotline, the car was towed to a workshop (SME Motor Pte Ltd).

We furnish this accident report. As no party involved suffered injuries, per the advice of the hotline consultant, a police report was not required.

All particulars and photos are hereby provided below.

It would be appreciated if my appointed agent (SME Motor Pte Ltd) is able to help facilitate and coordinate with BudgetDirect Insurance to get the car fixed as soon as possible.

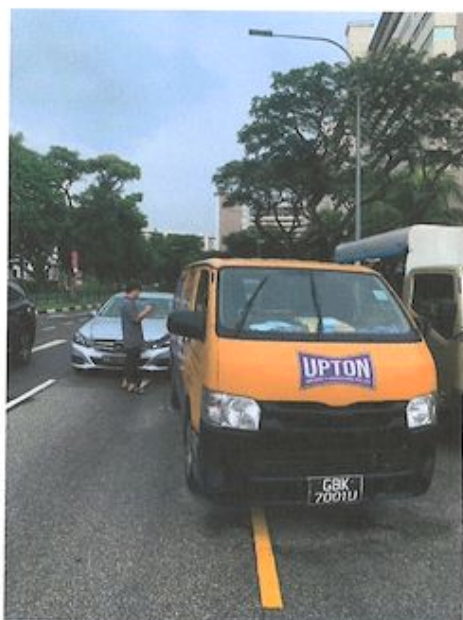







