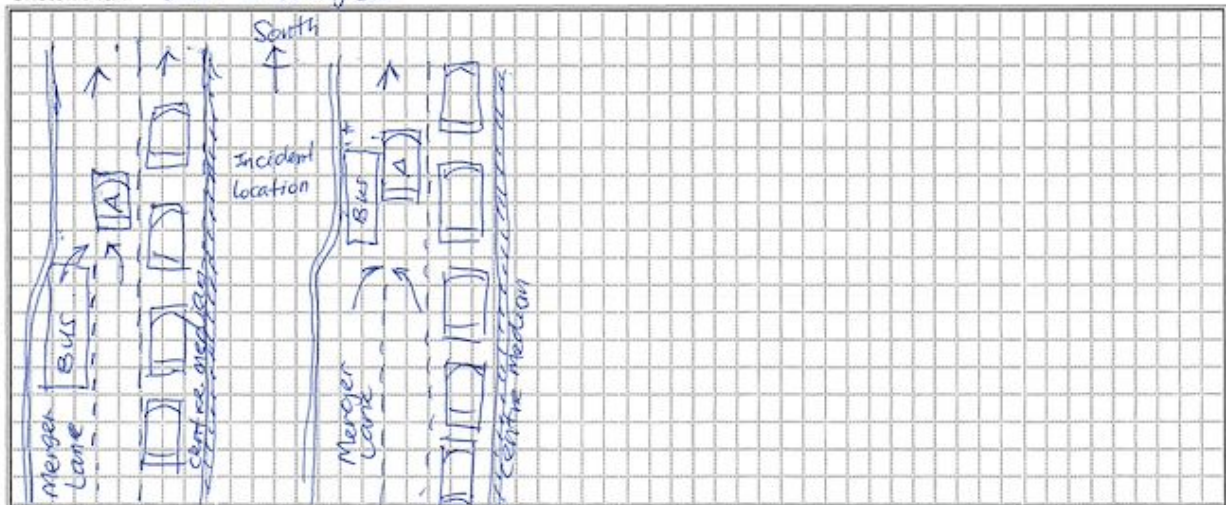

Describe Circumstance of the Accident

On 28/10/2022 at about 9.05a.m., my car was travelling from PIE exiting to Bedok North Ave.3.
On safe basis, my car was on centre 2nd lane of the 3-lane part of the Bedok North Ave.3. At some distance behind my car, there was a bus travelling from the northern side of Bedok North Ave.3. Near the merger lane part of the road, my car was still in front. However, for whatever reason, the bus suddenly "merged" into my car causing some scratches on the left side of my car and also hit onto the left side mirror of my car and at the left tail end.

Bedok North Ave 3 at this time of the weekday morning is still heavy with traffic. The merger lane scenario had caused the incident for whatever reason as my car was in front of the bus just before the incident.

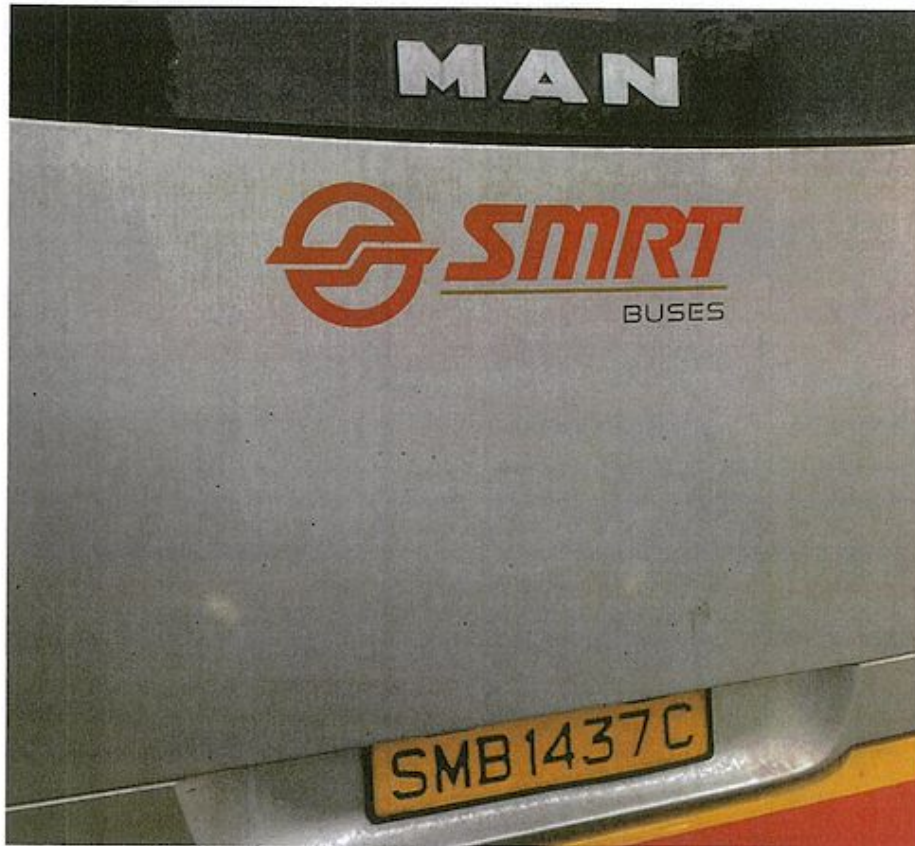

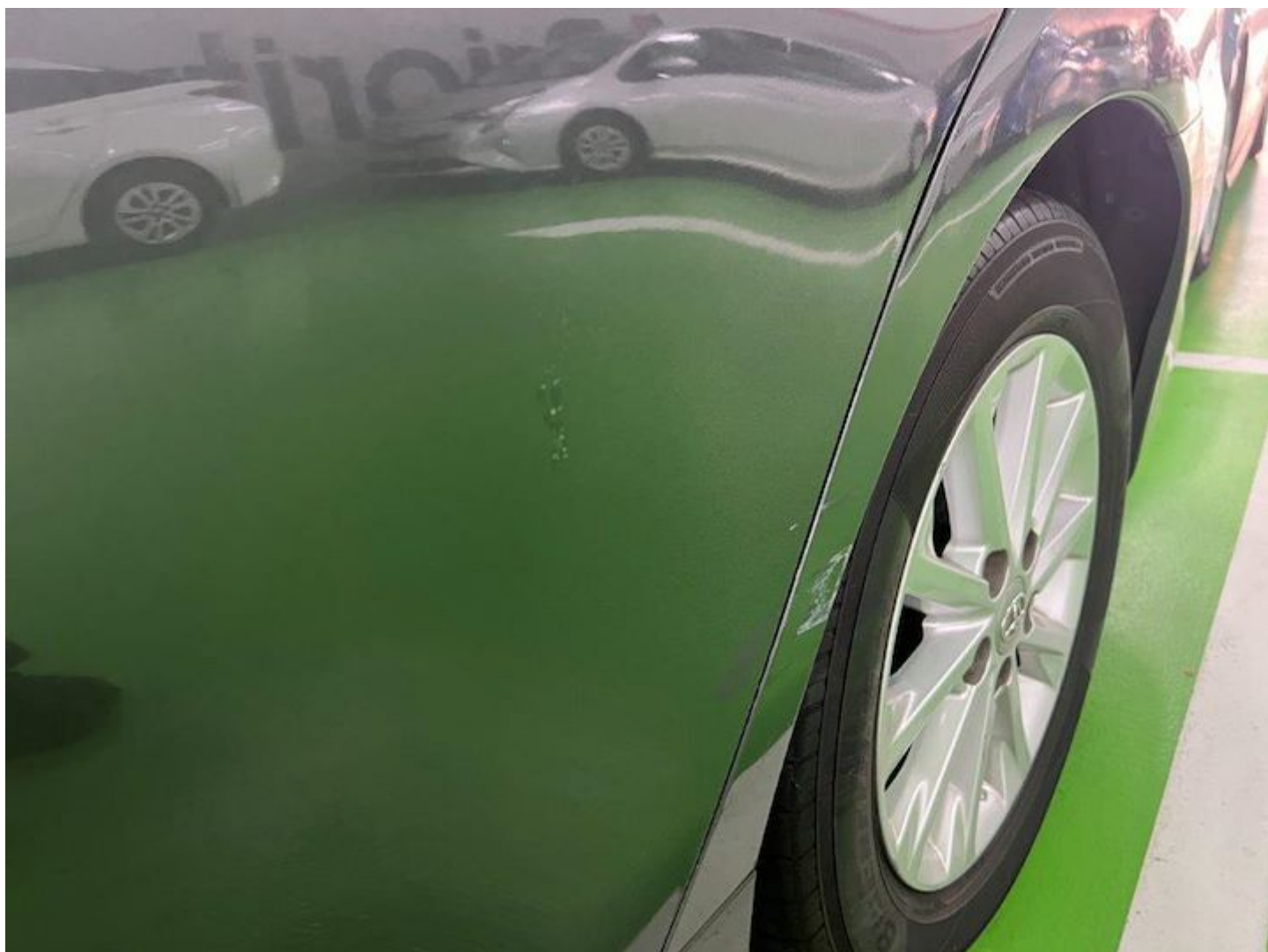
