
## AUTHORIZATION TO ACT




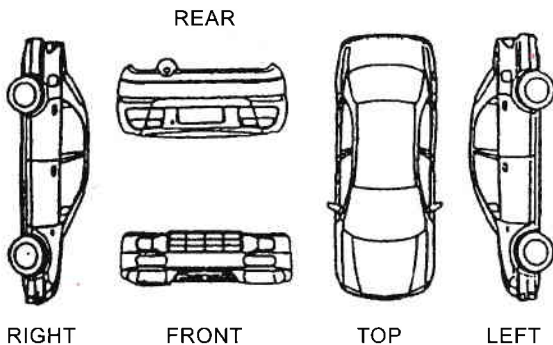
