#### CIRCUMSTANCES OF ACCIDENT

I WAS STOPPED AT THE T-JUNCTION OF SIANG KUANG AVENUE AND JALAN WANGI PREPARING TO TURN RIGHT INTO JALAN WANGI. I WAS ON THE WAY HOME WITH MY FAMILY. THERE WERE CARS ON JALAN WANGI, SO I GAVE WAY AND WAITED FOR THEM TO PASS. A LORRY WENT BY FIRST, FOLLOWED BY THE THIRD-PARTY VEHICLE. I WAS SPEAKING TO MY WIFE AND THOUGHT THAT THE VEHICLE WAS GOING STRAIGHT, AND ACCELERATED TO TURN RIGHT FOLLOWING HIM. HOWEVER, THE VEHICLE WAS TURNING RIGHT INSTEAD OF GOING STRAIGHT. BY THE TIME I REALISED THIS, I SLAMMED THE BRAKES RIGHT AWAY, BUT IT WAS TOO LATE. MY CAR HAD COLLIDED WITH THE RIGHT DOOR OF THE VEHICLE. WE BOTH PARKED THE VEHICLE, AND EXCHANGED INFORMATION. THERE WERE NO INJURIES TO ME OR MY PASSENGER, AND THE OTHER DRIVER ALSO DISPLAYED NO SIGNS OF INJURY.

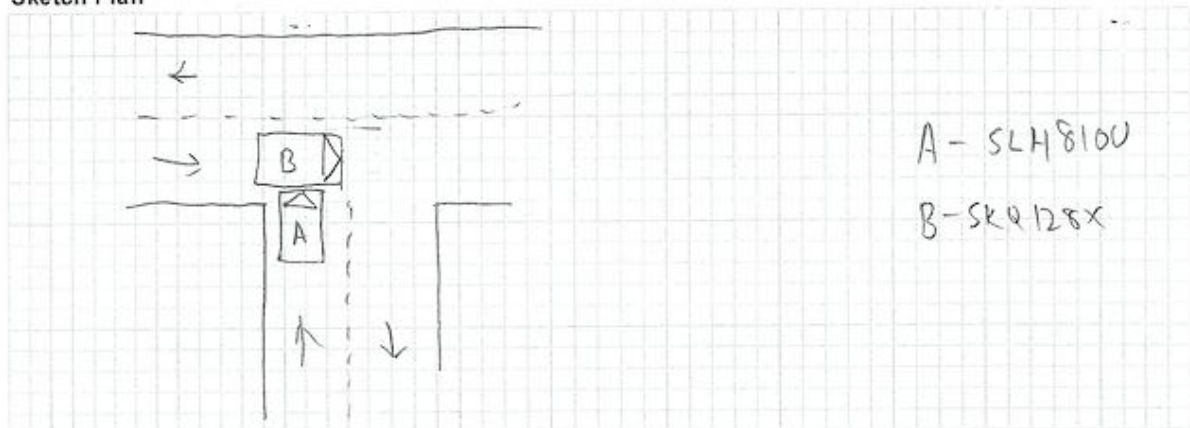

**Describe Circumstances of the Accident**

I was stopped at the T-Junction of Siang Kuang Ave and Jln Wangi preparing to turn right into Jln Wangi. I was on the way home with my family.

There were cars on Jln Wangi, so I gave way and waited for them to pass. A lorry went by first, followed by the third party vehicle. I ~~thought~~ was speaking to my wife and thought that the vehicle was going straight, and accelerated to turn right following him.

However, the vehicle was turning right instead of going straight. By the time I realised, I slammed the brakes right away, but it was too late. My car had collided into the right door of the vehicle.

We both parked the vehicle, and exchanged information. There were no injuries for me or my passenger, and the other driver also displayed no signs of injury.
